The copies of Recruitment Rules are enclosed for information and necessary action please. It is also stated that CPWD and DDA are departments under the jurisdiction of the same Ministry i.e MOUD, but the promotional hierarchy and pay scale of ministerial cadre are showing the discrimination being faced by the ministerial cadre in CPWD.

It is also stated that, MoUD has called for the information from Bharat Sanchar Nigam Ltd. vide OM No. 45(1)/(4)/2013-S&D/EWII dated 30-11-2015. In this regard, it has been informed in response to our RTI that the OM has not been received in their office. However, we placed the same under RTI Act and the information provided by BSNL Jt. GM & CPIO(Pers.Cell) vide their letter No. 140-03/2016-CSS dated 17-2-2016 (copy enclosed) which contains the following promotional hierarchy along with pay structure in the Bharat Sanchar Nigam Ltd.

Keeping in view of the facts stated above, it is a shocking fact that the ministerial cadre of CPWD have been deprived right of natural justice, which we are demanding since beginning, whereas the same has been positively heard by 7th CPC and recommended in their report vide Para 11.52.20 that " they are of the view that the matter is administrative in nature and may be decided by the Ministry itself." The comments of our Association in this regard forwarded to MoUD by the CPWD authorities vide OM No. 55/4/2014-S&D/41 Dated 12 Jan. 2016 with the remarks that "which is agreed in principal for submission to the concerned authorities."
