Revered Sir,

With reference to the above cited subject, we would like to refer this Association's letter of even No. 71 dated 05.03.2018 and the discussion with your good self in the meeting on 06.03.2018 held at the Conference Hall, Nirman Bhavan on the proposed cadre review in respect of Group 'A' Services and subordinate Engineering and Architecture Cadre of CPWD including other cadres. As we have already explained through various letters to several authorities of CPWD, Ministry of Housing and Urban Affairs and also in the said meeting that more than 35% posts of all categories of ministerial cadre allocated through last cadre review of Ministerial Cadre-2012 are still lying vacant at All India level, out of which more than 65% are lying vacant in the Northern Region only due to negligent attitude of Regional Co-ordinations especially DDG(Coord.) NR.
