Most Revered Sir,

It is our pleasure to bring your kind attention that the promotion to the all posts of ministerial cadre are not being done in time in spite of repeated requests made by this association and following meetings were conducted with various level officers as detail given below:-

Unfortunately nothing has been happened since then except few promotion orders issued, as no proper action has been initiated by the CPWD Directorate and Regional Co-ordinations to implement the cadre review of Ministerial cadre since 2012 and the directions issued by the Directorate.

We are enclosing the copy of Information received from the Coordination (NR) through RTI Act vide letter dated 26-05-2017 (Copy enclosed) the information is very surprising and shocking that the Exam Quota for the post of UDC has not been filled since implementation of new Recruitment Rules by misinterpretation of rule, and the error has not been corrected so far in spite of issuance of necessary clarification by the Directorate vide letter No. 12/30/2016-EC-IV(SC) dated 20-09-2016 resulting more than 65% vacancies are left in Northern Region for each posts of the Ministerial Cadre (Copy enclosed) thereby the Ministerial Cadre is facing penalty of withholding promotion without any default.

As per the table attached with this letter as **Annexure-1**, it can be seen that more than 25% of all posts are laying vacant, out of which more than 66% of overall vacancies are exists in Northern Region for a long period even after repeated requests by this Association and existing staff are overburdened. And also, the legitimate right of promotion to the staff is being denied deliberately as the employees are retiring /retired without their due promotion. At the same time, the promotion of the technical staff/officers are being issued and implemented timely which is again showing the step-motherly treatment of the CPWD Directorate towards the Ministerial cadre having a sizeable strength of more than 4418 Nos. + MTS-3617 = 8035. Owing to the aforesaid situation many litigation cases are filed by the staff of the ministerial cadre before the Hon'ble CAT and higher courts and also some other case likely to be filed, we feel that the CPWD authorities are challenging our patience and thereby provoking us for protest.

It is, therefore, requested your personal intervention and take up the matter for immediate action on promotions to different posts of the Ministerial Cadre with seniority form the retrospective date of vacancy as per the guidelines issued by the DoPT so that the staff can get their legitimate right and also the vacancies can be filled up which will help and boost the administration in its functioning.

We also demand that an enquiry may be ordered to investigate the cause/reasons for delay in promotion and how many officials have been retired without getting their legitimate right of promotion due to delay on the part of the Department, and action may be initiated against those responsible for such gross negligence.
