**Sub: Submission of confirmation of deduction of subscription from salary by the Concerned DDOs in respect of members of WR – Regarding.**

**Madam,**

kindly recall the discussion with Regional Executive Committee at the time of visit to Mumbai during 19<sup>th</sup> June to 21 June, 2017 and several requests over telephone with your good self and other Executive members for submission of confirmation of deduction of subscription from salary by the DDOs in respect of the members of Western Region for the year 2016-17, but it is regretted to point out that the Executive Committee of Western Region has miserably failed to submit required documents for the year 2016-17 in time, except few letters. Keeping in view of the revalidation of the Association, the required information was personally collected by the Central Executive Body for onward submission to the Directorate. It is also surprising that the Executive Body (WR) has failed to submit DDO letters of all their Executive Body members at least.

Now, the available documents have been submitted to the Directorate but keeping in view of the above circumstances the Central Executive body observed that the Regional Committee of WR is not taking active participation in the welfare of members of WR and not keen to maintain essential provision under the RSA Rules-1993 which would create problem for continuance of recognition of the Association.
