Sub: Implementation of 'Bhavishya' pension module and training thereof to Assistant Administrative Officers and Office Superintendents posted all over India-reg.

Respected Sir,

With reference to the above cited subject, kindly refer this Association's letter of even No. 4 Dated 19-01-2017, wherein it was elaborated that in central government offices, the "Bhavishya" module for processing of pension case has been implemented by the Government of India. **As such the Assistant Administrative Officers posted in CPWD who have been declared as Head of Office and have been assigned the duties of Drawing and Disbursing Officer are facing the problem in processing of pension cases after implementation of 'Bhavishya' i.e after March 2016, without proper training and requested the Directorate to conduct sufficient training to the staff for successful implementation of the this Pension Module.**

We are receiving several requests from the members to intervene in the matter for early conducting of the training on "Bhavishya" module. It is also informed that participation level of training programmes at the National CPWD Academy is EEs and AEs whereas AAOs and OS have not been given proper training. As the AAOs and OS are dealing pension cases at primary stage of submission of pension cases therefore it is necessary that they may be given proper training immediately to avoid delay in finalization of pension as well as to avoid the growing pension public grievance cases.

It has also been observed that the training calendar issued for northern region, only one day training programme on 'Bhavisha' is scheduled on 9-8-2017 with the participation level of AAO, OS and UDC, which is in-sufficient keeping in view of the strength of for northern region.

In this connection, a list of pending pension cases was circulated by the Directorate in this month and a meeting was also called under the chairmanship of the Chief Controller of Accounts in the Directorate wherein many doubts were cleared and suggestions were given with assurance of cooperation from the Pay and Accounts offices. It was also made clear in the said meeting that the delay in finalization of pension cases will be taken seriously by the ministry as well as Govt. Of India and necessary action will be initiated against the DDOs. Need of immediate training was also requested by our staff side in the meeting and the officer attending the meeting from the Directorate side was also instructed to make the arrangement for training of the staff by the Chief Controller of Accounts.

In view of above, it is requested to kindly look in to the matter and make suitable arrangements for training of 'Bhavishya' module to all the Assistant Administrative Officers and Office Superintendents exclusively at the earliest in National CPWD Academy and all Regional training institutes otherwise Directorate will be responsible for any delay or action against our members.

An early action in the matter is highly solicited.
