

Sir,

With reference to the above cited subject and reference, I may kindly be permitted to put forth my request in few lines as details given below:

At present I am working as Office Superintendent in the office of the Executive Engineer, Goa Central Division, CPWD, Goa under Goa Central Circle, CPWD, Goa. One office superintendent post is also posted at Goa Central Circle, CPWD, Goa against the Sanctioned Strength. There is no Sanctioned Strength of the post of Assistant Administrative officer at Goa Central Circle, CPWD, Goa.

I am due for promotion from the post of Office Superintendent to Assistant Administrative Officer and the orders are likely to be out very soon and I may be posted in a place anywhere in India. I am due for retirement on Superannuation in Service this year only in November 2018. If I am promoted and posted outside Goa for a short period for hardly any months left to retire will put me in great difficult position in the last stage of my retirement.

Therefore my humble request is that on my promotion to the post of Assistant Administrative Officer, I may be retained in Goa only as Assistant Administrative Officer in Goa Central Circle, CPWD, Goa till I retire which is a very short period please.

I would be very much grateful to you for a sympathetic consideration of my application to retain me in Goa as Assistant Administrative Officer by diverting a post of Assistant Administrative Officer in Goa please.

If I am posted at Goa on my promotion to the post of Assistant Administrative Officer I can dedicate myself totally on my job and work peacefully without tense before my Retirement period on Superannuation in service please. Moreover if I am retained in Goa station only instead posting me out of Goa for hardly any months, the Government Exchequer will be saved for paying me Composite Transfer Grant, Actual fares, Road mileage for journey, Cost of transportation of personal effects and Cost of transportation of personal effects please and vise-versa back to home town.

So my case for posting at Goa may please be considered, for which I shall ever remain grateful to you sir.
