We would like to extend our sincere gratitude to your good self for giving a meeting to this Association in person on 16th March, 2018 in spite of your busy schedule and heard the agonies of the Ministerial cadre of CPWD. As per the discussion and decided by your good self, this Association adduced the brief notes on major issues to your good self with copy to the Director General, CPWD for information and taking necessary action vide this Association's letter of even No. 74 dated 27-03-2018 on the following issues:-

- 1. Pay Parity to Ministerial Cadre of CPWD with CSS Cadre
- 2. 34 Posts of Administrative Officer.
- 3. Arbitration award for 40% higher posts against the sanctioned Strength of Office Superintendents.

During this month, this Association tried our best for getting a meeting with DG,CPWD and other higher authorities for resolving the long pending issues related to Ministerial Cadre, especially the inordinate delay in promotion to all the posts of Ministerial Cadre, for which a detailed vacancy position of posts at All India level have been produced before the Directorate with copy to all regional SDGs vide Association letter of even No. 75 dated 1-4-2018(Copy enclosed), but the result is still same, as neither the promotion order has been issued so far for any ministerial post nor the notification has been issued for conducting exam for filling the vacancies of UDC under exam quota for last four years.

Sub: Delay in promotion to the post of Assistant Administrative Officer and Office Superintendent at all India level.

Most Respected Sir,

We, would like to refer the decision of the Joint Secretary (W&H) MoUD issued vide Memorandum No. 752658/JS(W&H)/2016/EW-II dated 13th May, 2016 wherein the Directorate and DDG(Coord.)NR was directed to fill all the vacancies without further delay, in this connection kindly refer our letter No. GBCPWDOSAAI/39 dated 2-6-2017 addressed to Joint Secretary(W&H) MoUD containing the details of all Vacant Posts of Ministerial Cadre in CPWD region wise as on 1-6-2017, which was forwarded to the Directorate and the same was further forwarded to all DDG(Coord.) for taking action for filling up all the posts of Ministerial Cadre by promotions, further the same detail of vacant posts of Ministerial Cadre of all regions was submitted to the Directorate with position as on 31-01-2018 but no suitable action has so far been initiated to fill the vacant posts.

We would also like to recall the discussion held in the meeting held with Hon'ble Minister Of Housing and Urban Affairs on 16th March 2018 on the various issues related to ministerial Cadre wherein the issue of promotions of Ministerial Cadre was also discussed in detail and it has been assured by your good self that the promotion orders likely to be issued in coming fifteen days, in this connection some suitable directions were also suggested by the Hon'ble Minister of Housing and Urban Affairs for filling up all the vacant post within one month time.

in view of above facts, since no promotion orders have been issued so far, we are enclosing the details of vacant posts of Ministerial Cadre based on the information available on CPWD web site i.e PIMS as on 1-6-2017, 31-1-2018 and as on 1-4-2018 which clearly shows that in spite of repeated requests and pursuance made by this Association and communicated to all Coordination's, no suitable action has been initiated for filling of vacant posts of Ministerial Cadre through promotions.

In this connection, kindly refer the position of vacancies, you will find out that the position of Coordination (NR) is worst in all regions in spite of located at the headquarter station and the situation of vacant posts are increasing day by day which is more than 35% in NR region and as compare to vacant posts at all India level its comes to more than 65%, we are not sure that they are in position to fill all the promotional posts within one month time as desired by the Hon'ble Minister and committed by the Department side since 15 days already been elapsed. We have come to know that the seniority quota for the post of OS the DPC was conducted in the month of Nov-2017 but they are unable to take decision to issue the promotion orders and also the Exam quota for the year 2013-14 is ready but decision is still pending in spite of the directions by the Hon'ble CAT (PB) Delhi and contempt petition is also due in the matter. No examination for promotion to the post of LDC to UDC has been notified since last five years as per new Recruitment Rules.

Keeping in view of the facts, we are once again repeating that the all the AAOs and OS posted in Northern Region are facing very difficulties in carrying out the job assigned to them without availability of adequate staff at their offices. The ministerial cadre staff retiring from the service without getting promotion after serving the department more than 35 years with honesty and dignity with best of their abilities and they have been deprived from their legitimate rights and the continuous shortage of staff is also hampering the spirit of work which results the collapsing of the administration of the department.

Under this pressing situation, We feel that your good self will try to understand the agony of the ministerial cadre and will issue the suitable directions to concerned officers for filling up the all promotional post by issue of promotion orders without further delay.
