Most Respected Sir,

With reference to above cited subject, kindly refer our letter even No. 89 dated 25-06-2018, wherein we would like to refer the DoPT OM No. 38/37/2016-P&PW(A) dated 6th July, 2017 vide which the directions have been issued for revision of pension/family pension of pre-2016 w.e.f. 1-1-2016 in accordance with using the concordance tables enclosed with the said OM.


While going through the Concordance tables, it has been observed that the table NO. 24-25 shows that the pay scale 6500-200-10500 has been replaced with pay band-2 Rs. 9300-34800 GP 4200 instead of GP-4600, same discrepancies have been noticed in others tables i.e. 26-27 which is clearly indicates that proper placement has not been given to the pensioners/family pensioners for revision of pension as per the recommendations of 7th CPC.

In view of the above, this Association is forwarding, a grievance received from Sh. M. C. Kapoor, Office Superintendent Grade-1 (Retired) addressed to your good self for rectification of discrepancies, Sh M. C. Kapoor retired from the CPWD on 30-11-2003 in the pre revised scale of pay 6500-200-10500. Further we are also receiving many telephonically calls from the retired employees of the CPWD on the issue, but in spite of laps of four months no communication regarding action taken for rectification of discrepancies has been received to this Association

Therefore, we once again requested your good self for taking up the matter with the appropriate authority for rectification of the discrepancies in the concordance tables, and settle the matter once for all the cadres of the department
