Sub:- Revival of Departmental Council under the SCHEME FOR JOINT CONSULTATIVE MACHINERY AND COMPULSORY ARBITRATION FOR CENTRAL GOVERNMENT EMPOYEES

Respected Sir,

As you are aware, the Government of India introduced the SCHEME FOR JOINT CONSULTATIVE MACHINERY AND COMPULSORY ARBITRATION FOR CENTRAL GOVERNMENT EMPOYEES in 1966 and decided to establish a machinery for joint consultation and arbitration of unresolved differences with the object of promoting harmonious relations and of securing the greatest measure of co-operation between the Government, in its capacity as employer, and the general body of its employees in matters of common concern, and with the object, further, of increasing the efficiency of the public service.

While the National Council will deal with matters affecting Central Government employees generally, a Departmental Council will deal only with matters affecting staff employed in the department or departments concerned.

The JCM Scheme provides for Departmental Councils at the level of individual Ministries/Departments, including their attached and subordinate offices. However, regular dialogue with the Staff Side through the mechanism of Departmental Councils at Ministry/Department level is not happening. Meetings of Departmental Council are essential at periodic intervals as they help in resolving differences between the Government and the Staff Side.

The DoPT, New Delhi vide their OM No. F. No. 4/3/2009-JCA dated January 30, 2017 informed that they have been issuing instructions from time to time for holding regular meetings of Departmental Council with a view to making effective use of Joint Consultative Machinery (JCM) Scheme. They had also requested to furnish information on holding of meetings of Departmental Councils vide their D.0 letter of even no. dated 02.11.2016. Copy of circulars referred above is enclosed herewith for your ready reference please.

In view of the above, it is requested that necessary immediate steps may be initiated to set up a Departmental Council under the JCM Scheme inviting all stake holders to participate in the Scheme and nominate their representatives to the Council for the welfare of the staff side as well as betterment of the Department.

The undersigned is directed to say that this Department has been issuing instructions from time to time for holding regular meetings of Departmental Council with a view to making effective use of Joint Consultative Machinery (JCM) Scheme. In this regard a D.O letter of even no. dated 02.11.2016 (copy enclosed) regarding furnishing information on holding of meetings of Departmental Councils was sent earlier.

- From the information received, it is noted that Departmental Councils have not been constituted in all Ministries/Departments and in some cases, though the Departmental Councils have been constituted, regular meetings are not being held.
- The JCM Scheme provides for Departmental Councils at the level of individual Ministries/Departments, including their attached and subordinate offices. The Staff Side of JCM, however, has been remonstrating that regular dialogue with the Staff Side through the mechanism of Departmental Councils at Ministry/Department level is not happening. Departmental Council are essential at periodic intervals as they help in resolving differences between the Government and the Staff Side.
- It is, therefore, requested that the relevant information, as asked for, on the Departmental Council meetings held may kindly be sent at the earliest.

2			According to the provisions of the Scheme, representation on a Joint Council can be had by employees of any particular grade only through their Association/Union, duly recognized for the purpose. Therefore, before any category of staff can be considered eligible for representation on a Joint Council, they would have to organize themselves into an Association / Union and get it recognized Employees. who do not do so, will not be eligible for representation on a Joint Council. It is hopped that in order to get the benefit of the Scheme the Staff will gradually organize themselves and form Association/Union in order to get representation on the Council.
