
Sub: Non Implementation of Transfer Order in respect of Sh.
Virender Singh, Officer Superintendent.

With reference to above cited subject, Sh. Virender Singh, Office Superintendent posted at Garwal Central Division since 11-07-2014 has applied for transfer to Delhi on the basis of illness of his wife (Medical Grounds) and his request was considered by the competent authority and transfer orders were issued vide your office order No. 21(4)/2016/DDG(Coord.)NR/Civil-1/oS/2743 dated 23-11-2016 without TA/DA, but the official was not been relieved by the concerned Executive Engineer till date in-spite of repeated requests made by the official on the basis of medical condition of his wife as such the official is facing acute mental harassment.

Now, the official has completed his tenure at the station on 11-07-2017 and also has attained the age of 58 years (Date of Birth on 15-06-1959) and having less than two years of service, his transfer order may please be altered as "on public interest" with the direction to concerned office to relieve him immediately without waiting for substitute failing which the controlling office may be held responsible for any miss-happening with his wife as her medical conditions are very serious and will be liable to pay the compensation, if any, under the provision of law.

An early action in the matter is highly solicited.
