Sub:-Pending promotion to various posts of Ministerial Cadre resulting deprival of legitimate right of promotions to the eligible staff -regarding.

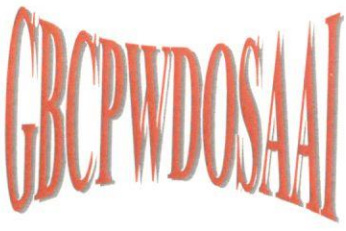
Most Respected Sir,

Kindly refer to this association's earlier letter of even letter of even number 39 dated 02-06-2017 and reminder letter No. 44 dated 5-07-2017 on the above subject wherein the details of Sanctioned Strength with in-position and status of vacant posts have been elaborated to your good self. It is an astonishing fact that more than 25% of all posts are lying vacant and out of it, more than 66% of overall vacancies are in Northern region only for a long period. Promotion is the legitimate right of the staff whereas the same is deprived to them for the reasons best known to the Department.

We requested your personal intervention vide our letter under reference, but unfortunately, no change has been seen in two month time. It is stated that **the Department has miserably failed to fill the vacancies of Ministerial Cadre it created five years ago and it seems that cadre review was an eye wash or a cruel joke for ministerial cadre whereas the cadre review was a privilege to facilitate the "Group A" officers of CPWD only.**

Earlier, the Co-ordinations were headed by SEs' and the promotions and transfer/posting were carried out promptly. Since the cadre review, It can be seen from the posting details of DDG (Coord.)NR that the post is being utilized for preparation of retirement or to enjoy promotion before retirement and is limited to the issue of transfer/posting orders of Engineering...

cadre only, not for the promotion and transfer/posting of Ministerial Cadre and almost every officer posted in the Coordination are keen to complete their tenure only. Whenever the association demands for promotion, they simply issue letters for sending APAR or VCC Performa, and no serious effort was made and it resulted the vacancies are not filled for the last five years creating unrest and agonies among the Ministerial staff.

It is, therefore, once again requested your personal intervention in the matter with DG, CPWD for immediate action on promotion to different post of ministerial cadre and demand your good self to order an enquiry for delay in promotion as many officials have been retired without getting their legitimate right of promotion due to delay on the part of Department and action may be initiated against those responsible for such gross negligence.

We also intimate that if promotion orders are not issued in a month's time from the date of issue of this letter, this Association will be forced to take necessary action as deemed fit at appropriate time like demonstration or march to the office of Prime Minister of India for seeking redressal of our legitimate and justified demands.
