With reference to the above cited subject, kindly refer this Association's letter of even No. 93 dated, 22-06-2016, and the decisions taken in the meeting on 1-6-2016 with the members of this Association under the chairmanship of SDG (NR), on various issues related to AAO & OS mainly "Promtion". The brief of the discussions were forwarded for taking necessary action at your end please.

it is also regret to mention here that in spite of repeated pursuance with your office as well as DDG(Coord.)NR, the minutes of the meeting has not been issued so far which it self destruct the purpose of the meeting as well as clear violation of the instruction issued vide Directorate's OM NO. 43/1/2016-General Dated 13th April, 2016 regarding issue of minutes of the meetings. Further, we requested for a meeting with SDG(NR) vide our letter No. 42 dated 15-06-2017 after a period of one year of first meeting (dt. 01.06.16) with details of pending demands with the Region but we are still waiting for response.

The DDG (Coord.)NR was also requested over telephone fifteen days ago for a short meeting to discuss and resolve the pending issues but the request was denied for the meeting stating busy schedule.

In this connection, it is stated that in the past the Co-ordinations were headed by SEs' and the promotions and transfer/posting were carried out promptly. Since the cadre review, It can be seen from the posting details of DDG (Coord.)NR that the post is being utilized for preparation of retirement or to enjoy promotion before retirement and is limited to the issue of transfer/posting orders of Engineering cadre only, not for the promotion and transfer/posting of Ministerial Cadre and almost every officer posted in the Coordination are keen to complete their tenure with ease. Whenever the association demands for promotion, they simply issue letters for sending APAR or VCC Performa, and no serious effort was made and it resulted the vacancies are not filled for the last five years creating unrest and agonies among the Ministerial staff.


**Keeping in view of the above, it is requested that a meeting with this Association may please be fixed immediately to resolve the issues related to Ministerial cadre for welfare of the staff and betterment of the Department also, failing which this Association is left with no other option except demonstration in front of Regional Headquarter/Nirman Bhavan or other higher offices as deemed fit, for which the Department will be held responsible.**
