**Sub: Regarding non implementation of decisions taken in the Meeting held on 29-04-2016 under the chairmanship of DDG(HQ).**

**Revered Sir,**

With respect, we would like to draw your kind attention towards the meeting held under the chairmanship of DDG(HQ) by this Association on 29-04-2016 and this Association's letter of even No 101 Dated 29-8-2016, regarding stagnation of Ministerial Cadre staff of CPWD. Important issues were discussed in detail in the said meeting wherein Executive Engineer (Coord.)NR was also present and decisions were taken and communicated vide Office Memorandum No. 4/2/2016-EC-IV(SC)/925 Dated 25<sup>th</sup> May, 2016, but it is pertinent to mention that in spite of laps of more than six months further, no action taken report or status of implementation of decision were communicated to this Association. The details of the main agenda discussed and decisions taken and present status pertaining to Coordination (NR) are mentioned as under:-

**Non filling of vacancies of OS in all regions resulting in stagnation-** It has been stated that there are so many vacancies in the grade of O.S. The DDG (HQ) has agreed to look into the matter and directed the Executive Engineer (Coord.) (NR) to speed up the process of the promotion of UDC to the post of O.S without further delay.

The Director (Admn.II) was also directed to issue necessary instructions to all SDGs of Regions for immediate attention to this matter and speedy action to avoid further delay.

It was also suggested that the department may look into the feasibility of meeting with aggrieved parties who have gone to CAT case for promotion to the post of O.S. with the mediation of Association for betterment of cadre and promotional channels.

It is once again mentioned here that after repeated requests and intervention in the matter for allotment of funds for mandatory training with CCA, MoUD for allotment of funds and also after urgent meeting with Chief Engineer (Trg.) National CPWD Academy, two training batches were specially conducted in Regional Training Institute R.K.Puram, New Delhi. But after laps of more than six months the ministerial cadre is still waiting for their legitimate right of promotion.

It is also pertinent to mention here that the delay in promotion is badly affected Northern Region, as vacancies of the post of OS in Northern Region is more than 85% of overall vacancies of OS in all over India.

We would like to reiterate once again that the delay in promotion is on the part of the Department not on the individual, hence the promoted OS later on shall be allowed to avail seniority with retrospective date of the vacancy at all India level to meet their legitimate right of promotion to the grade of AAO at right time and seniority which have already been informed to the Department well in time


