Respected Sir,

With reference to above cited subject, DDG(Coord)NR has circulated the readiness list of Office Superintendents posted under Northern Region for rotational transfer under the region in the month of January 2017, but no transfer orders issued so far. We would like to refer CPWD Regular Establishment and Office Procedure-2013, Para 12.5 (iii) regarding procedure for rotational transfer which clearly state that **"The transfer orders should normally be issued in the month of March / April so that the officers can move before commencement of the academic year."**

It has also been observed that many UDCs promoted to the post of Office Superintendent have been posted out of station in spite of available vacancies at the same station and also due to inordinate delay in promotion by the office of DDG (Coord.)NR, the officials forgo their promotion, which have been accepted by the Coordination (NR) without considering the pros and cons resulting neither the officials have been promoted nor further promotion orders issued immediately and all vacancies remain vacant till date.
