**Most Revered Sir,**

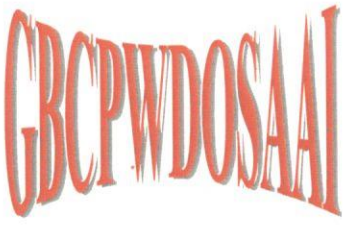
**We would like take this opportunity to congratulate you for promotion to the post of DG and wish you all the best for the present Endeavour.**

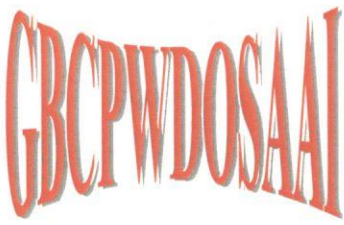
