Sub: Pending Promotions to various posts of Ministerial Cadre resulting Deprival of Legitimate right to eligible staff - regarding.

Respected Sir,

We, would like to refer the decision of the Joint Secretary (W&H) MoUD issued vide Memorandum No. 752658/JS(W&H)/2016/EW-II dated 13th May, 2016 wherein the Directorate and DDG(Coord.)NR were directed to fill all the vacancies without further delay, in this connection kindly refer our letter No. GBCPWDOSAAI/39 dated 2-6-2017 addressed to Joint Secretary(W&H) MoUD containing the details of all Vacant Posts of Ministerial Cadre in CPWD region wise as on 1-6-2017, which was forwarded to the Directorate and the same was further forwarded to all DDGs(Coord.) for taking action for filling up all the posts of Ministerial Cadre by promotions, further the same detail of vacant posts of Ministerial Cadre of all regions was submitted to the Directorate with position as on 31-01-2018 but no suitable action has so far been initiated to fill the vacant posts.

We would also like to recall the discussion held in the meeting with Hon'ble Minister Of Housing and Urban Affairs on 16th March 2018 on the various issues related to ministerial Cadre wherein the issue of promotions of Ministerial Cadre was also discussed in detail and it has been assured by the then Director General, SDG(NR) and ADG(S&P) who were present in the meeting that the promotion orders likely to be issued in coming fifteen days, in this connection some suitable directions were also suggested by the Hon'ble Minister of Housing and Urban Affairs for filling up all the vacant post within one month time.

In view of above facts, the promotion orders to the post of Assistant Administrative Office for the vacancy year 2017-18 have been issued by the Directorate and about 60 promotions orders to the post of Office Superintendent were issued by the DDG(Coord.)NR, but large number vacancies of Office Superintendent, & UDCs are still vacant.

We are enclosing the copies of this Association letter No. GBCPWDOSAAI/40 dated 09-06-2017, 75 dated 1-04-2018 and 88 dated 19-06-2018, wherein the details of vacant posts of Ministerial Cadre based on the information available on CPWD web site i.e PIMS as on 1-6-2017, 31-1-2018, 1-4-2018 and as on 19-06-2018 were informed to the Directorate with copy to all SDGs, which clearly shows that in spite of repeated requests and pursuance made by this Association and communicated to all Coordinations, no suitable action has been initiated for filling of vacant posts of Ministerial Cadre through promotions.

In this connection, kindly refer the position of vacancies, you will find out that the position of Coordination (NR) is worst in all regions in spite of located at the headquarter station and the situation of vacant posts are increasing day by day which is more than 35% in NR region and as compare to vacant posts at all India level its comes to more than 65%, we are not sure that they are in position to fill all the promotional posts within another one month's whereas seven months is over after the commitment made to the Hon'ble Minister by the Department side. We have come to know that No examination for promotion to the post of LDC to UDC has been notified since last five years as per new Recruitment Rules.

The DDG (coord.)NR issued a panel for promotion from UDC to OS vide OM dated 07-09-2018 with calling the copy of APAR/VCC/ACC/Training details etc. it was the perception of all the ministerial cadre that the said OM is only eyewash as they are aware that It is not possible to complete in a short time as both the officers are going to retire in the month of October, 2018 which was endorsed by the DDG(Coord.)NR vide OM dated 18-10-2018 that the last date of sending information has been extended to 07-11-2018.

Keeping in view of the facts, we are once again repeating that the all the AAOs and OS posted in Northern Region are facing difficulties in carrying out the job assigned to them without availability of adequate staff at their offices. The ministerial cadre staff retiring from the service without getting promotion and also loosing the benefit of MACP in next grade due to delay in promotion after serving the department more than 35 years with honesty and dignity with best of their abilities and they have been deprived from their legitimate rights and the continuous shortage of staff is also hampering the spirit of work which results the collapsing of the administration of the department.
