Sir,

With reference to above cited subject, Provisional Seniority List of Office Superintendent in CPWD at All India Level as on 01-04-2017 was circulated vide Directorate OM No. 3/3/2017-EC.IV(SC) Dated 10-04-2017 and all the concerned officials were requested to go through the details in the seniority list and intimate discrepancies, addition and deletion, if any, to the Directorate.

After careful examination of the provisional Seniority list, it has been observed that the Provisional Seniority list has been issued in a very casual manner without proper checking and compilation of Seniority lists of Office Superintendents issued by the regional co-ordinations, without deleting the names of office superintendents who have been promoted to the post of AAO during the year and without including the names of the officials promoted to the post of office Superintendents during the year etc., which will create dispute of Seniority and promotion process and also un-necessary litigations in the matter.

Keeping in view of the sensitivity of the matter, this Association requests your personal intervention in the matter and also request that the provisional Seniority list may be issued afresh based on the seniority lists issued by the regional co-ordinations.
