Sub: Various pending issues related to Assistant Administrative Officers, Officer Superintendents and Ministerial cadre of CPWD - regarding.

Most Revered Sir,

With reference to the above cited subject, we would like to draw your kind attention towards the Directorate's Office Memorandum No. 4/2/2016-EC-IV(SC) Dated 13th June, 2016 whereby the minutes of the meeting held under the Chairmanship of JS(W&H) with the office bearers of this Association on 05-05-2016 were forwarded to All regions for taking necessary action. We would like to draw your kind attention towards the point No. 4 of the minutes wherein it has been directed by the JS(W&H) to issue an advisory to the DG,CPWD to take a meeting with the Association once in every quarter to explain their issues so that their demands/issues can be addressed in a better manner. It is regretted to point out that in spite of repeated requests with the then Director General, no meeting was given to this Association, and your good self were also requested for the same but we are still eagerly awaiting for a meeting to express our agonies.

After great pursuance by this Association, we have been given a hearing by the ADG(S&P) in Oct. 2016 and favorable decisions were taken in the meeting but action is still awaited even minor corrections in an order suggested by this association have not been done so far. Besides this, meeting were also done with other Officers and the result is the same. This Association made lot of correspondence with every authority on various issues but no reply has been received so far from any authority of the Department.

It is also observed that when the dealing hand of EC-IV(SC) section remains on leave, no work is carried out in respect of Ministerial cadre of CPWD because in spite of a large number of posts only one UDC is deputed for all works of Ministerial cadre barring issuance to vigilance clearance certificates. After observing the facts and circumstances, a review has been done by this association on its own and to the sheer surprise it is found that for Class-A cadre of 1500 Officers four sections of the Directorate are deputed to look after their work whereas for more than 8,000 Ministerial officials/officers only one UDC is being deputed for looking after such a huge strength of staff.

It is also seen that there are three Assistant Administrative Officers deputed in EC-II(A) and EC-II(B) section to look after the Transfer posting, Promotions and Esstt. Matter of just 879 Executive Engineers, There are four Sections for Class A officer of 1500 Nos. and only one UDC for more than 8000 ministerial staff which itself clearly shows the discrimination with the Ministerial Cadre and one dealing hand can never do the job promptly and efficiently.

Keeping in view of the above circumstances, this Association strongly demands your good self to look into the matter personally and request:-

- An Urgent Meeting may be given to this Association to discuss all pending issues related to AAO/OS and Ministerial Cadre.
- A Separate shall be opened exclusively for ministerial Cadre with adequate staff for each category of the Ministerial Cadre.
- 3. An Assistant Administrative Officer should be deputed in the Section as Section in charge.
