No action has been taken by the Department to resolve the case in spite of repeated request made by this Association, However Hon'ble CAT(PB), New Delhi announced the decision in the favor of the applicants vide Judgment dated 31.08.2017 in OA No. 347/2014 in the matter of Smt. Shobhna Sharma & others V/s CPWD regarding Promotion to the post of Office Superintendent under Exam Quota for the Examination conducted on 8th and 9th December 2012 against the vacancies of the year 2012-13 and declaration of result of Examination Conducted on 8-3-2014 and 9-3-2014 against the vacancies for the year 2013-14.

In this connection DDG(Coord.)NR declared the vacancies for the year 2012-13 and 2013-14 vide their Office memorandum No. 21(4)GA/2017/DDG(Coord.)NR/EE(C)-I/OS/ 3114 dated 17-11-2016.

It is stated that after the repeated intervention in the matter by this Association and having a formal meeting with DDG (Coord.)NR, the revised result for the Exam conducted on 8th and 9th December 2012 was declared by the DDG (Coord.)NR vide their Office memorandum No. 9(7)GA/2013/DDG(Coord.)NR/GA/ 3260 dated 08-12-2017 with option of station for posting with the last date 15-12-2017.

The staff side repeatedly requesting the department since 2012 and no positive attitude was shown by the Department for solving the issue, and even after the judgment of Hon'ble CAT(PB) dated 31.08.2017 in OA No. 347/2014 in favor of the staff, no promotion order has been issued so far and more than 90 days lapsed after the judgment, it seems that the Department is waiting for a **contempt petition**.

This Association is dealing the matters of Ministerial Cadre but almost every cadre is facing delay in promotional matters. While going through the previous record, it has been observed that the problem in delay of the promotion was started in every Region from the date of creation of the post of Deputy Director General in Coordinations. Earlier, Coordination Circles were being running promptly under the supervision of Superintending Engineers and even by the Executive Engineer also, without any delay in promotion or conducting Exams. Therefore, this is a matter of review of the policies by the department. We are once again mentioning the fact that the officers posted in the office of DDG(Coord.)NR are enjoying their posting for preparation of retirement only and the work was delayed by waiting the decisions to be taken by the successors only.

Keeping in view of the circumstances stated above, we request your good self :

- 1. That promotion orders in respect of Office Superintendents under Exam quota of 50% for the year 2012-13 (as per revised result for the Exam conducted on 8th and 9th December 2012 was declared by the DDG(Coord.)NR vide their Office memorandum No. 9(7)GA/2013/DDG(Coord.)NR/GA/ 3260**
