Promotion of Ministerial Cadre-calculation of vacancy regarding.

Sir,

With reference to the subject of delay in promotion of various posts of Ministerial cadre as discussed in detail in the meeting with Hon'ble Minister of HUA on 16-03-2018 and a vacancy position of ministerial cadre at all India level intimated vide this association letter of even No.75 dated 1-4-2018, the representatives of this Association met Special Director General (NR) on 20-04-2018 to resolve the issue of delay in promotion. The matter was discussed in detail with SDG (NR) in the presence of Deputy Director General (Coord.) NR.

After the discussion, this association felt that the concept of calculation of vacancies is not clear to the Coordination (NR) which is the main cause of the delay in the promotion of ministerial cadre. It seems that Coord.(NR) is confused in maintaining the roster for promotion as the new recruitment rules changed the criteria of Seniority and Exam quota for promotion to the post of LDC to UDC. In this regard we referred the direction of the Directorate issued vide letter No. 12/30/2016-EC.IV (SC) dated 28th July, 2017.

In view of the above, we request your good self to kindly issue general guidelines regarding calculation of vacancies and maintaining of roster to avoid further delay in promotion of the ministerial cadre.
