Respected Sir,


Kindly refer the application of Shri Florence Edward Fernandes, Office Superintendent posted in the O/o SDG(NR), CPWD, Sewa Bhavan, New Delhi addressed to your goodself and copy endorsed to this Association on the above mentioned subject (copy enclosed herewith for ready reference).

In this connection, it is stated that this Association has requested the Directorate several times to look into the issue of correctness of the roster of AAO and also offered voluntary service of one of our member for this purpose. Unfortunately, our request was not heard properly and no communication received from your side so far about the proper maintenance of the roster.

From the application of Shri Fernandes OS under reference, it is clear that there are still discrepancies in the roster of AAO and the Directorate is not taking any serious step to rectify the same even after repeated requests of this Association.

It is, therefore, requested your good self to kindly look into the matter and remove the discrepancies if any, under intimation to this Association so that the promotion process can be undertaken properly and right man get the promotion at the right time.

Sub : Promotion of Office Superintendent to the post of Assistant Administrative Officer for the vacancy year 2016-17.

Ref : Directorate General's Office Order No. 14 of 2017 issued vide No. 5/3/2016-EC.IV(SC) dated 09/02/2017.

Sir,

Please refer to your above mentioned Office Order vide which two Office Superintendents - Sh. Dilip Kumar belonging to Scheduled Caste Category and Sh. Devki Prasad belonging to Scheduled Tribe category - have been promoted to the post of Assistant Administrative Officer against Unreserved vacancies of Smt. Anju Chadha and Smt. Neeru Arya retiring on 28/02/2017. In this connection it is stated that the vacancies of Smt. Anju Chadha and Smt. Neeru Arya belonging to Unreserved Category ought to have been filled up by way of promotion of Unreserved category Office Superintendent, instead of through reserved category employees.

It is intimated that out of the total Sanctioned posts of 162 of Assistant Administrative Officer in the Department, 24 posts are reserved for Scheduled Caste Category and 12 posts for Scheduled Tribe category according to post based roster. Copy of table showing roster points for reserved category is enclosed. On the basis of Final seniority list of Assistant Administrative Officer as on 01/04/2016 circulated vide Directorate's O.M. No. 3/8/2010-EC.IV(SC) dated 17/06/2016 and various promotion orders issued thereafter, the vacancy position as on date (15/02/2017) should be as per the under mentioned table :-

In the seniority list issued on 17/06/2016, AAOs shown at Sl. No. 7, 9, 73, 74, 75, 76, 78, 80, 81, 82, 83, 84, 85, 86, 117, 118, 119, 120, 121, 122 and 123 (total **21**) belong to **Scheduled Caste** Category. AAOs at Sl. No. 7, 74, 117 and 121 (total **4**) have retired till 31/01/2017. Similarly AAOs shown at Sl. No. 1, 10, 72, 77, 79, 87, 88, 89, 90, 124 and 125 (total **11**) of the Seniority List belong to Scheduled Tribe category, against the reserved Sanctioned Strength of **12**.

As can be seen from the above table, there is vacancy of 1 Scheduled Caste category and 1 Scheduled Tribe category as on 15/02/2017, against which orders of Sh. Dilip Kumar and Sh. Devki Prasad ought to have been issued instead of the Unreserved vacancies which will arise on 01/03/2017.


