Sub: Delay in promotion to the post of Assistant Administrative Officer and Office Superintendent at All India level due to delay in decision on reservation in promotion to SC/ST Candidates.

Most Respected Sir,

We, would like to refer the discussion held in the meeting with Hon'ble Minister of Housing and Urban Affairs on 16-03-2018 and this Association letter of even No. 75 dated 1-4-2018 wide which the detail of vacant posts of Ministerial Cadre in the department at all India level was intimated to your good self for taking necessary action for filling up the vacancies by the promotion.

While personal enquiry from the Directorate we have come to know that the promotions are being delayed due to taking decision on reservation in promotions to the SC/ST Candidates, as the Directorate has already issued the directions to the cadre controlling authorities vide its OM No. 23/31/2017-EC.I(B) dated 2-2-2018 without consulting the DoPT. In this regard this Association met Deputy Director General (HQ) two months ago and suggested to take the clarification from the DoPT to protect the rights of the members of this Association as well as all ministerial cadre to avoid the clash or unnecessary litigation in the matter, but it is regretted to point out that no remedial action has so far been initiated by the Directorate to resolve the issue and the promotions of ministerial Cadre are being delayed due to pending decision on reservation in promotion to SC/ST candidates and the whole ministerial cadre has been deprived from their legitimate right of promotion either they belongs to reserve category or non reserve category, resulting the situation the VCC in respect of promotion to the post of OS to AAO was lapsed and therefore further exercise has been carried out by the Directorate to recall the Proforma 'B' for VCC and administrative Clearance recently.
