Sub: Improper cancellation of promotion orders in respect of Office Superintendents – regarding.

Most Respected Sir,

We would like to refer Deputy Director General (Coord.)NR Office Order No. 185/2016 issued vide No. 21(4)/2016/DDG(Coord.)NR/Civil-1/OS/2743 dated, 23-11-2016 vide which 64 UDCs were promoted to the post of office Superintendent and posted various offices located at various stations under Northern Region, with specific directions which is reproduced below:-

“If any Upper Division Clerk neither give refusal in writing nor accept the promotion and does not join the duty in office of his posting on promotion as Office Superintendent within 30 days of issue of this order, it will be presumed that the concerned official has not accepted the promotion & his/her orders shall be treated as cancelled. No separate cancellation order will be issued.”

In this connection, kindly refer Deputy Director General (Coord.)NR Office Order No. Order No. 37/2017 issued vide No. 21(4)/2016/DDG(Coord.)NR/Civil-1/OS/825 dated, 16-03-2017 and 162/2017 issued vide No. 21(4)/2016/DDG(Coord.)NR/Civil-1/OS/2888 dated, 17-10-2017 regarding cancellation of promotion in respect of 8 Nos and 12 Nos UDCs have been issued with the remarks that the promotion orders are cancelled with the request of individuals and in compliance with Dopt OM No. 22011/5/86-Estt(D) dated 10-04-1989 and they have been debarred for promotion for a period on one year w.e.f. 16-03-2017 and 17-10-2017 respectively.

The order of DDG(Coord.)NR dated 16-03-2017 and 17-10-2017 is itself violating their own order dated 23-11-2016 which says that **"If any Upper Division Clerk.....No separate cancellation order will be issues."** It means those who neither given the refusal in writing nor joined the office on promotion to the post of Office Superintendent their cancellation will be treated w.e.f. 23-12-2016 and they will be considered for promotion after one year i.e. w.e.f 23-12-2017.

But the 8+12=20 UDCs who have submitted their representation due to their personal, compelling circumstances or change of posting etc., the Coordination NR took time of four and eleven months respectively to take the decision on their representations and accept the forgo of promotion with the date of issue of cancellation of promotion Order which was not necessary as per the instructions in the promotional order and they have further been punished for representing their problems.

Now as per the circumstances explained above, there are two categories of UDCs who have not accepted the promotions against Deputy Director General (Coord.)NR Office Order No. 185/2016 issued vide No. 21(4)/2016/DDG(Coord.) NR/Civil-1/OS/2743 dated, 23-11-2016:-

1. Those who are not accepted the promotion and not even represented for retention or change of posting etc. and they will be eligible for promotion again after one year and 30 days of issued of the orders i.e. w.e.f. 23-12-2017 whereas ;
2. Those who are represented for retention or change of posting etc. will be eligible for promotion only after one year of issue of cancellation orders i.e. w.e.f. 16-03-2017 and 17-10-2018 respectively.

As this is a clear cut case of discrimination among the ministerial cadre and this Association feels that such activities are being adopted to delay the promotions of the ministerial cadre and the Coordination (NR) repeatedly trying to create disputes or unnecessary litigations in promotional matters. The case of Shobhna Sharma and others is a perfect example in this context.
