
Revered Sir,

With reference to above cited subject, It has already been explained by various letters to DDG(HQ) and SDG(NR) and also discussed in the meeting held on 29-04-2016 under the chairmanship of Deputy Director General (HQ) and in the meeting on 01-06-2016 under the chairmanship of Special Director General (NR) that the promotion to the post of Office Superintendent in Northern Region has been badly delayed due to timely non conducting of Mandatory training, non preparation of roster, APAR, VCC etc. for which the individual official is not responsible, therefore they may be allowed to avail seniority with retrospective date of vacancy for all India level seniority to meet their legitimate right of promotion to the grade of AAO at right time.

It is regretted to point out that in spite of repeated requests by this Association, no action has so far been taken to allow seniority from the retrospective date of vacancy to Office Superintendent of Northern Region who have been promoted after delay on the part of the Department for the reasons explained above.

Keeping in view of stated above, this Association demands that the report for delay in promotion may please be obtained from the Coordination (Northern Region), R.K.Puram, New Delhi and suitable action for fixing of seniority at all India level may be initiated and correct seniority may be given to all Office Superintendents of northern region to achieve their legitimate right of promotion to the post of Assistant Administrative Officer at right time.
