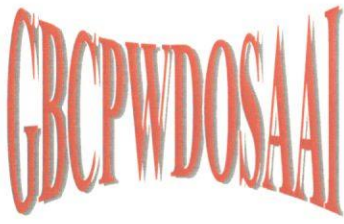

Sir,

Please refer the Directorate's OM, on above cited subject, vide which Provisional Seniority List of Office Superintendent at All India Level, in CPWD as on 01-04-2017 was circulated vide Directorate OM No. 3/3/2017-EC.IV(SC) Dated 10-04-2017. In this regard it is intimated that the discrepancies observed in the seniority list were intimated vide this association letter No. 30 dated 20-04-2017. It was also requested to your good self that the Seniority lists of Office Superintendents may be issued on the basis of seniority lists issued by the regional co-ordinations, and should also include the names of the officials who were promoted to the post of office Superintendents during the year etc.

In spite of all possible efforts by the association, It is regretted to point out that the seniority list is still full of discrepancies and is required to be rectified and needs to be properly checked before issue, For instance the name of Sh, G.P.Singh at S.No. 238 in the list of NR has not been included in the list of All India level, whereas the name of Sh. Som Nath at S.No. 420 and Sh. Sudama Singh Negi at S.No. 422 have been included though their names did not exist in list of NR.

We would also like to refer to our following letters addressed to various levels of officers for granting of seniority to OS of NR who have been promoted late due to delay on the part of the Department. This matter was also discussed in the meeting with your good self on 25-04-2017 and it was agreed in principle that the official may be allowed to grant the seniority at appropriate place as per vacancies of the particular year against which they have been promoted but in the provisional seniority list, the OS of NR have been denied the legitimate right of their seniority and have been granted seniority from the date of actual promotion, instead of vacancy year.
