**Sub : Benefit of Bunching in Pay fixation to Head Clerk (New Office Superintendents) as per the recommendations of 6<sup>th</sup> CPC chapter-4, Part-B Section-II, Para sub Para II.**

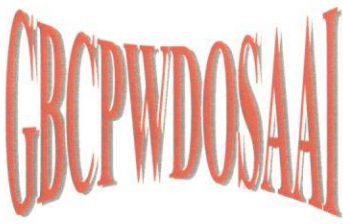
Respected Sir,

With reference to above subject, kindly refer this Association letter of even No. 22 dated 20-03-2017 regarding benefit of bunching in pay fixation to Head Clerk (Now Office Superintendents) as per the recommendations of the 6<sup>th</sup> CPC Report, Part-B, Section-II, wherein a specific recommendations for up-gradation of pay scale of Office Staff working in Organizations outside the Secretariat i.e. Head Clerks in CPWD have been given whereby pre-revised pay scale of Rs. 5000-8000 has been upgraded to revised pay scale of Rs. 6500-10500. ( reproduced as under):-

**6<sup>th</sup> CPC chapter-4, Part-B Section-II, Para sub Para II.**

- (i) **The revised pay structure mentioned in columns (5) and (6) of the part of the Notification for the posts mentioned in column (2) have been approved by the Government. The initial fixation as on 1-1-2006 will be done in accordance with Note: 2 below Rule-7 of this Notification.**
- (ii) **On account of merger of pre-revised pay scales of Rs. 5000-8000, Rs. 5500-9000 and Rs. 6500-10500, some posts which presently constitute feeder and promotion grades will come to lie in an identical grade. The specific recommendations about some categories of these posts made by the pay commission are included Section II should be merged. In case it is not feasible to merge the posts in these pay scales on functional considerations, the posts in the scale of Rs. 5000-8000 and Rs. 5500-9000 should be merged, with the post in the scale of Rs. 6500-10500 being upgraded to the next higher grade in pay band PB-2, i.e. to the grade pay of Rs. 4600 corresponding to the pre-revised pay scale of Rs. 7450-11500. In case a post already exists in the scale of Rs. 7450-11500, the post being upgraded from the scale of Rs 6500-10500 should be merged with the post in the scale of Rs. 7430-11500.**

Note:2 below Rule-7 of this Notification -

Where a post has been upgraded as a result of the recommendations of the sixth CPC as indicated in Part B or Part C of the First Schedule to these Rules, the fixation of pay in the applicable pay band will be done in the manner prescribed in accordance with Clause (A) (i) and (ii) of Rule 7 by the multiplying the existing basic pay as on 1-1-2006 by a factor of 1.86 and rounding the resultant figure to the next multiple of ten. The grade pay corresponding to the upgraded scale as indicated in Column 6 of Part B or C will be payable in addition. Illustration 4A in this regard as in the Explanatory Memorandum to these Rules.

Clause (A) (i) and (ii) of Rule 7

- (i) The pay in the pay band/pay scale will be determined by multiplying the existing basic pay as on 1-1-2006 by a factor of 1.86 and rounding off the resultant figure to the next multiple of 10.
- (ii) If the minimum of the revised pay band/pay scale is more than the amount arrived at as per (i) above, the pay shall be fixed at the minimum of the revised pay band/pay scale.

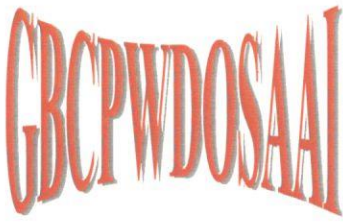
Provided further that:-

Where, in the fixation of pay, the pay of Government servants drawing pay at two or more consecutive stages in an existing scale gets bunched, that is to say, gets fixed in the revised pay structure at the same stage in the pay band, then, for every two stages so bunched, benefit of one increment shall be given so as to avoid bunching of more than two stages in the revised running pay bands. For this purpose, the increment will be calculated on the pay in the pay band. Grade pay would not be taken into account for the purpose of granting increments to alleviate bunching.

It is surprising to note that Directorate vide O.M. No. 8/52/2011-EC.III dated 10/03/2017 have given benefit of fixation of pay in pre-revised pay scale of Rs. 7450-11500 (multiplication of 7450\*1.86=13860) with benefit of bunching to them w.e.f. 1-1-2016 in terms of recommendations of 6<sup>th</sup> CPC Report, Part-C, Section-II to Assistant Engineers (Civil & Electrical) only, and left the erstwhile Head Clerks (Now Office Superintendents) and other CPWD cadres who are supposed not to be influential and have been deprived of their legitimate right.

Keeping in view of the above facts, this association once again strongly demands that the discrimination between cadres may be stopped immediately and necessary orders granting bunching benefits and fixation of pay in respect of Head Clerks (now Office Superintendents) may be issued at the earliest, so that these officials may also get the benefits of recommendations of the 6<sup>th</sup> CPC Report, failing which there are possibilities to cropping up so many un-necessary litigation in this issue.

An early action in the matter is highly solicited.
