with retrospective effect i.e. from the Vacancy year.**

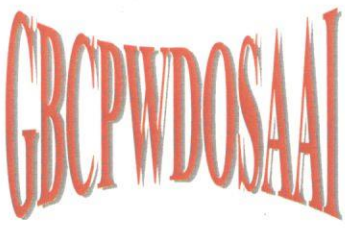
Most Respected Sir,

We would like to refer this Association letter of even No. 51 Dated 11-08-2017 vide which a meeting was requested with your good self to resolve the various pending issues especially promotional matters related to the ministerial cadre, but we are still waiting for a call from your office.

With reference to above cited subject, we would like to refer the meeting held with the then SDG(NR) on 1-6-2016 wherein various issues were discussed in detail and decisions were taken but the minutes of the said meeting was not issued by your office which was issued vide this association vide letter even No. GBCPWDOSAAI/93 Dated 22-06-2016 addressed to your good self.

As you are aware, the office of DDG(Coord.)NR is absolutely failed to issue the promotion orders in time in respect of Ministerial Cadre in spite of repeated requests made by this Association with various level of officers of department as well as JS(W&H) MoUD on 5-5-2016. In the said meeting which was attended by Sh. I.D.Yadav EE(HQ) Coord.(NR), the minutes were issued vide Memorandum No. 752658/JS(W&H)/2016/EW-II dated 13th May, 2016 wherein the DDG(Coord.)NR was directed to fill all the vacancies without further delay but even after one and half years the vacancies are still lying vacant from the year 2013-14 onwards, affecting the ministerial cadre especially Office Superintendents as they are being placed far behind in the seniority of Office Superintendents at all India level without any default on their part thereby they are losing their Seniority for promotion to the post of Assistant Administrative Officer at appropriate time and have also been deprived their legitimate right of promotion and financial benefits in time.

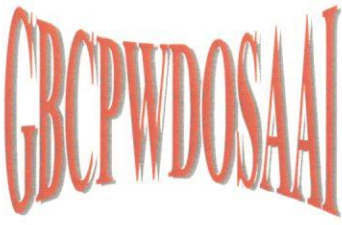

In the meeting held with SDG(NR) on 1-6-2016, the matter was discussed in detail and the then DDG(Coord.)NR was directed to take up immediate appropriate action with the Directorate to solve the issue, another meeting was held in the Chairmanship of DDG(HQ) in the Directorate on 25-04-2017 and the minutes of the said meeting was issued vide Directorate OM No. 4/2/2016-EC.IV(SC) dated 2-5-2017 wherein at S.No-3, it has been stated that the promotion from UDC to OS and seniority list of OS pending with DDG (Coord.)NR.

We would like to refer that this association has repeatedly requested almost every authority of the department to resolve the issue of OA filed in the Hon'ble CAT by Smt. Shobna Sharm and others out of Court and DDG (Coord.)NR was also requested in this regard, but it is regretted to point out that no action was initiated by the DDG(Coord.)NR to resolve the issue. Now the decision of Hon'ble CAT(PB) has been announced in the favour of the petitioners and the promotion order have been issued by the DDG(Coord.)NR vide Office Order No. 11 of 2018 and issued vide No 21(4)/DDG(C00rd.)NR/EE(C)/GA/2018/455 Dated 15-02-2018 without allowing seniority from the retrospective date of vacancy year even the department is loser side of the petition and fails to protect their decision of non promotion and the result of exam conducted for the vacancies for the year 2013 and Exam held on 8-3-2014 and 9-3-2014 was also declared vide OM No21(4)/DDG(C00rd.)NR/EE(C)-1/GA/2018/542 Dated 26-02-2018 for which the promotion orders likely be issued very soon but it is not sure whether they will be placed in Seniority of retrospective date of vacancy year or they will also be deprived as others.

We are very much surprised that in the similar matter of delayed promotions to the post of LDC to UDC Exam Quota, the promotion orders have been issued by the DDG(Coord.)NR vide Office Order No. 154 of 2017 and issued vide No 21(3)/DDG(C00rd.)NR/EE(C)/E-4/2017/2754 Dated 28-09-2017 with the Seniority from the retrospective date of Exam.

Similarly we would like to refer the case of Sh. Inder Mohan Ahuja, he was also been deprived the promotion owing to some error which was sort out later and he was promoted to the post of Office Superintendent vide DDG(Coord.)NR vide Office Order No. 21 of 2014 and issued vide No 21(4)/2014/DDG(COOrd.)NR/GA/466 Dated 25-02-2014 under Exam Quota and have been allowed the Seniority with effect from 27-03-2012 vide DDG(Coord)NR letter No.21(4)DDG(Coord.)NR/2016/2378 Dated 04-10-2016 by the Executive Engineer (Civil)-1 in own capacity as mentioned in the order. But in the present case, the Office Superintendents have been deprived from Seniority and their legitimate right, surprisingly by the same office by adopting the different and pick and choose method.

In view of the above circumstances, this Association humbly requests your good self to intervene in the matter and the Office Superintendents promoted delayed due to administrative reasons and also on the part of the Department may be allowed the Seniority from the retrospective date of vacancy years to save their legitimate right of promotion to the post of Assistant Administrative Officer at appropriate time and also to avoid the further litigation in the matter.

If desired by your good self, we are ready to discuss the matter in person also.
