The undersigned is directed to convey the approval of the competent authority to authorize expenditure on hospitality facilities in respect of Senior officers of Directorate (Head Quarter) CPWD, Nirman Bhawan, New Delhi only as per the following monetary ceiling **with effect from 01.03.2018:-**



2. The above hospitality facilities will be claimed only by officers (Sl. No.4 to Sl. No. 10) who are controlled by ADG (TD/S&P/Border) and posted in Nirman Bhawan, New Delhi in the Directorate only.

3. The entitled officers may avail the hospitality through the CPWD departmental canteen (at 4th Floor, C-Wing, Nirman Bhawan, New Delhi) or the Cafeteria operationalised by the MoHUA, subject to the overall ceiling so prescribed above.

4. Responsibility for observing the ceiling on hospitality/entertainment from all sources mentioned above, lies with the respective officers. In case the total expenditure exceeds the revised ceiling limit as prescribed above, the excess amount will have to be borne by the officer concerned and there will be no carry forward of un-utilized amount of the limit prescribed to the next month or transfer of amount from one officer to another. There should be a single claim for the concerned month in respect of the officer having charge of more than one seat.

5. This issues with the concurrence of IFD, MoHUA.
