**Assistant** to benefits bunching Sub: Extending Administrative Officers in CPWD on account of upgradation of pre-revised pay scale from 6500-200-6<sup>th</sup> CPC 7450-225-11500/as per 10500/recommendations- reg.

Respected Sir,

With reference to the above cited subject, kindly refer this Association's letter of even No. 24 dated 29-03-2017. But the request of this association for extending bunching benefit to AAOs was turned down by the Directorate vide O.M. referred above. In this regard, it was brought to your kind notice vide this Association's letter of even No. 41 dated 14-06-2017 that it is true, the post of AAOs is not found mentioned under M/o Urban Development in Part C/Section -II of the Gazette Notification dated 29.08.2008 issued by Deptt. Of Expenditure, Ministry of Finance, but the Directorate while examining this case, deliberately/inadvertently did not take note of full contents of the letter, specially the reference of M/o Finance, Department of Expenditure, Implementation Cell, OM No.1/1/2008-IC dated 13/11/2009, wherein the pay scale of Rs.6500-10500 has been upgraded to next higher grade in the pay band PB-2 with Grade Pay Rs.4600/-corresponding to the pre-revised scale of Rs.7450-11500 and decided the issue in a hasty and casual manner and it is a glaring example of discrimination exhibited towards the ministerial cadre.

Your kind attention is also invited towards the Part A Section-I of Gazette Notification dated 29.08.2008 wherein normal placement of scale have been mentioned and the pay scale S-12, 6500-10500 was place in PB-2 9300-34800 GP 4200, in this connection kindly refer M/0 Finance, Department of Expenditure, Implementation Cell **OM No. 1/1/2008-IC dated 13<sup>th</sup> November**, **2009 wherein** the pay scale of Rs.6500-10500 being upgraded to next higher grade in the pay band PB-2 with grade pay Rs.4600 corresponding to the pre-revised scale of Rs.7450-11500. In case, a post already exists in the scale of Rs. 7450-11500, the post being upgraded from the scale of Rs.6500-10500 should be merged with

It is clearly mentioned in the para 3 of the above OM dated 13<sup>th</sup> November, 2009 that the matter has been considered and it has now been decided that the posts which were in the pre-revised scale of Rs. 6500-10500 as on 1.1.2006 and which were granted the normal replacement pay structure of grade pay of Rs. 4200 in the pay band PB-2, will be granted grade pay of Rs. 4600 in the pay band PB-2 corresponding to the pre-revised scale of Rs. 7450-11500 w.e.f. 1.1.2006. Further, in terms of the aforementioned provision of CCS(RP)Rules, 2008, in case a post already existed in the pre-revised scale of Rs. 7450-11500, the posts being upgraded from the scale of Rs. 6500-10500 should be merged with the post in the scale of Rs. 7450-11500. Further directions vide para 4 of OM dated 13.11.2009 that the pay will be fixed again in accordance with illustration 4A annexed to CCS(RP) Rules, 2008.

In this connection, we would like to refer letter dated 27-06-2017 received from Sh. Jai Narain Antil, Office Superintendent Grade-I (Retired) addressed to your good self with copy to Secretary, Urban Development and this Association, (Copy Enclosed) which is self explanatory and justified. We also agree with the view of Sh. J.N. Antil that the decision the Directorate may be re-considered keeping in view of the clarifications issued by the DoPT, failing which there are possibilities to cropping up so many un-necessary litigation in this issue. The 7<sup>th</sup> pay commission 10 years after the 6<sup>th</sup> pay commission implemented w.e.f.1.1.2016 and the recommendation of the 6<sup>th</sup> pay commission is delayed so long and the Ministerial Cadre of CPWD are suffering till date.

Sub: Request for extending the benefits of Bunching of stages in pre-revised scale from Rs. 6500-200-10500/- to Rs. 7450-225-11500/- as per recommendations of 6th CPC to the category/post of Assistant Administrative Officers(Erstwhile Office Superintendents Grade-I)in C.P.W.D. as on 01-01-2006-Reg.

Ref.: The Directorate General, CPWD, Office Memorandum issued vide No. 5/19/2017-EC IV (SC) dated 12th June, 2017received on 24-06-2017 in response to disposal of Appeal dated 14th June, 2017.

### Respected Sir,

Kind attention is invited to the Directorate General, CPWD on captioned subject and reference, wherein it has communicated that the request of Group "B" CPWD Office Staff Association (All India) and various representations received in the Directorate for consideration of extending the benefits of bunching in the pre-revised scale on account of up-gradation of their pay scale, duly examined in the Directorate and the same cannot be extended to AAOs in line with Assistant Engineers working in CPWD as the post of AAOs is not found mentioned under Ministry of Urban Development in Part C/Section-II of the Gazette Notification dated 29-08-2008 issued by Deptt. Of Expenditure(Ministry of Finance).

Notwithstanding, I had already elaborated detailed scenario and matrix regarding grant of pay scale and up-gradation/creation of post of Office Superintendent Grade-I[Group-B (Gazetted)] in CPWD as per recommendations madevide Para-89.25 by the 5th CPC as well grant of pay scale of Rs. 6500-200-10500/- and subsequent up-gradation of this pay scale to Rs. 7450-225-11500/- by the 6th CPC vide my representation dated 29th March, 2017. Thus, there is no need to explain or repeat the same again. However, the same is reiterated in the succeeding paras, for ready reference and convenience to re-consider the case/matter by the Directorate.

The disposal in question reflects that this has been dealt in a casual manner and without linking the rules and orders issued by the Department of Expenditure(Ministry of Finance), M/o DOPT and M/o Urban Development etc. from time to time related to this effect. In other words, I have no hitch in mentioning here that if the Directorate considered this matter in right perspective and as per spirit and extant instructions regarding extending the benefits of bunching of stages in pre-revised scales, thenunnecessary correspondence would have been avoided in addition to harassment to the applicant as well as other aspirants. The relevant rules

and regulations not only to 7th CPC, even 6th CPC and prior to that, are very well available on the web-site of DOPT & Ministry of Finance.

In addition to above, it is also pointed out that the copy of judgement dated 28-02-2013 in various OAs viz. 141/2012, 143/2012 & 145/2012 delivered by Honourable Tribunal, Jaipur and dated 10-04-2015 in OA No. 040/00111/2015 delivered by Honourable Tribunal, Guwahati to this effect are very much available in the Directorate itself.

Even Note dated 02-05-2016 issued by Department of Expenditure (Ministry of Finance) in a matter related to granting bunching benefit to Master Craftsman that Rule 7(1) A (ii) would apply in this case if the initial pay in the revised scale was fixed in this case under Rule 7(1) A (i) and the condition of the proviso to Rule 7(1) A (ii) are fulfilled-is also available with the Directorate, as supplied to me in response to RTI application dated 20-03-2017.

This has also already explained that the Directorate vide Office Memorandum No. 8/52/2011-EC. III dated 10<sup>th</sup> March, 2017, by mentioning therein that Department of Expenditure's O.M. No. 1/1/2008 – IC dated 30<sup>th</sup> August, 2008 and Rule 7(1)(a)(i) & (ii) of CCS (RP) Rules, 2008 as well as in consultation with IFD, M/o UD benefits of pay fixation and bunching of stageshas extended to the category of Assistant Engineers (Civil & Electrical) in CPWD-whose scales were up-graded as per 6<sup>th</sup> CPC Report/Recommendations.

It will not be out of place to mention here that prior to issue of these orders, the similar benefits were also extended to the Category of Assistant Director (OL) by the Directorate [ECIV (SC)] vide Office Memorandum No. 6/7/2010-EC IV (SC) dated 06<sup>th</sup> May, 2010, as communicated to me in response to RTI application dated 20-03-2017.

Thus, in view of explanations in the preceding paras and my representation dated 29th March, 2017, the afore-mentioned similar benefits should have to be extended/granted to the applicant along with other Superintendents Grade-I, who were in service as on 01-01-2006, on the analogy of equality and similarity. But it appears that the benefits of bunching of stages in pre-revised scale could not be extended/granted to the applicant & other Superintendents Grade-I, as accorded to the category of Assistant Engineers (C & E) and Asstt. Directors (OL) in CPWD and Master Craftsman w.e.f. 01-01-2006, owing toimproper feedback or other ill-motivated reasons best known to the Directorate. The disposal in question also proves poor knowledge and sub-standard working of the Directorate, specifically in respect of Section Officer, EC-IV (SC) and DDA concerned. Further-more it is added that I have come to know from reliable sources that since the matter regarding grant of this benefits to other some similar categories in CPWD, is being consideredfavourably in the Directorate, itself. This also reflects and proves discrimination as well as step-motherly treatment with the category of Superintendent Grade-I now re-designated as Assistant Administrative Officers in CPWD.

In addition to above, some other facts and circumstances related to this matter are being reiterated again for kind perusal and reconsideration as under:

- (i) That CCS (Revised Pay) Rules, 2008(Recommendations of 6th CPC) were notified vide G.S.R. No. 622 (E) dated 29th August, 2008, which were implemented all cadres/posts in all departments of Government of India, retrospectively i.e. 1st January, 2006.
- (ii) That in compliance to above mentioned Notification/GSR, Ministry of Finance (Deptt. Of Expdr.) (Implementation Cell) had further issuedinstructions regarding implementation of 6th CPCrecommendations-fixation of pay and payment of arrears w.e.f. 01-01-2006vide O.M. F. No. 1/1/2008-IC dated 30th August, 2008.
- (iii) That as per recommendations contained in Para-7.46.25 of 6th CPC, Pay Band (PB)-2 of Rs.9300-34800/- with Grade Pay of Rs.4200/-corresponding to the existing pay scale of Rs. 6500-10500/- was recommended/approved for the erstwhilecategory of Office Superintendents Grade-I& Grade-II in CPWD w.e.f. 01-01-2006 on the basis of improper justification/logic.
- (iv) That in Para-3.1.14 of 6th CPC also made general recommendations for non-Secretariat Organizationsi.e. the existing and revised structure in Field Organization will, therefore, be follows as mentioned therein, wherein the category of Office Superintendents, Superintendents and Assistant Admn. Officers along-with other so many categories of Field Organizations has also mentioned.
- (v) That it is more important to mention here that the post of Office Superintendent Grade-I was re-designated as Assistant Administrative Officer vide Directorate O.M. No. 48(1)/4/09/S&D/363 dated 13-06-2012, which was subsequent kept in abeyance. Consequent upon the approval of Honourable UDM, re-designation of the post of Office Superintendent Grade-I in Subordinate Ministerial Cadre in CPWD as Assistant Administrative Officer was revived with immediate effect by the Directorate as per order No. DG/CAD/161 issued vide No. 48(1)/4/2013/S&D/02 dated 02nd January, 2015.
- (vi) Thatthus, on the basis of gist of preceding paras, it is prima-facie proved that there was a mention this category under Ministry of Urban Development in the Gazette Notification dated 29-08-2008 issued by the Deptt. Of Expenditure, Ministry of Finance. Hence, the communication endorsed by the Directorate [ECIV (SC)] to this effect, seems to be very improper as well as illogic that the post of AAOs is not found under the Ministry of Urban Development in Gazette Notification dated 29-08-2008. Not only this, it also reflects that the concerned staffs of the Directorate does not even try to link the contents/recommendations made by the 5th CPC & 6th CPC, rather disposed off the matter in haste and casual manner.

- (vii) That the Honourable 6th CPCwas not aware of the facts and circumstances that the post of Office Superintendent Grade-I is a promotional post from the category of Office Superintendent Grade-II, which was created as per recommendations of Honourable 5th CPC vide Para-89.25, specifically in CPWD. Thus, owing to unawareness of this hierarchy and recommendations made by the Honourable 5th CPC as well as spirit of Arbitration Award-which was/is still in force specifically in CPWD for the category of Office Superintendents, the Honourable 6th CPC had proposed and recommended the merger of scales of Rs. 5500-9000/- and Rs. 6500-10500/- vide Para-7.46.25.
  - CPC 6th implementation of upon Report/Recommendations, ab-initio, the Association and applicant had made a lot of consequent representations/correspondence with various authorities regarding up-gradation of Grade Pay, specifically for this category, being Group-B (Gazetted) and having equality with the category of Assistant Engineers/Asstt. Directors (H) in CPWD, other and departments/subordinate offices as well as on the basis of having/discharging higher Ministries duties & responsibilities in addition to the existence of Compulsory Arbitration Award, specifically applicable to the category of Office Superintendents in CPWD since long back.
    - (ix) That ultimately, after detailed correspondence and length deliberations with various for aand being the genuine grievance/issue, Ministry of Finance, Department of Expenditure(Implementation Cell) accepted the proposal/references in general as elucidated in Office Memorandum issued vide F.No. 1/1/2008-IC dated 13th November, 2009.
    - (x) That it has specifically mentioned in the Para 3 of aforementioned O.M. dated 13th November, 2009that the matterproposing up- gradation of the posts which were in the pre-revised scale of Rs. 6500-10500/-ason 01-01-2006 by granting them Grade Pay of Rs. 4600/- in the pay band PB-2 has been considered and it has now been decided that the posts which were in the pre-revised scale of Rs. 6500-10500/- as on 1.1.2006 and which were granted the normal replacement pay structure of Grade Pay of Rs. 4200/- in the pay band PB-2, will be granted Grade Pay of Rs. 4600/- in the pay band PB-2 corresponding to the pre-revised scale of Rs. 7450-11500/- w.e.f. 1.1.2006.
    - (xi) That further, in terms of the aforementioned provision of CCS (RP) Rules, 2008, it is decided that in case a post already existed in the pre-revised scale of Rs. 7450-11500/-, the posts being upgraded from the scale of Rs. 6500-10500/-should be merged with the post in the scale of Rs. 7450-11500/- and also directed vide Para-4 that the pay will be fixed again in accordance with illustration 4A annexed to CCS(RP) Rules, 2008. This pay fixation formula under this rule to the category of Assistant Directors (OL) and Assistant Engineers as well as other similarly placed categories in CPWD was made applicable and effective w.e.f .01-01-2006.

- (xii) That the up-gradation was made effective from 1st January, 2006 and the contents of said O.M. are very much explicit in establishing complete parity with the posts already recommended for up-gradation, specifically for those posts which were in the pre-revised pay scale of Rs. 6500-200-10500/- as on 1st January, 2006.
- (xiii) Thatin compliance with afore-mentioned directions/instructions, **Grade**Pay of Rs. 4600/- in Pay Band (PB-2) of Rs. 9300-34800/- was granted and accordingly refixed the pay of the applicant from 1st January, 2006 by the office of Superintending Engineer, Coord. Circle (Civil), CPWD, New Delhi vide Office Order No. 9(4)/2009-Coord. Cir. (C) /EC/ 3819 dated 09-12-2009. Similarly, benefits in thiscategory/post toother Assistant Administrative Officers (Erstwhile Office Superintendents Grade-I) in CPWD as on 01-01-2006 were also granted to them, being their legitimate rights.
- (xiv) ThatHonourable 6th CPC(Para-II of Section-II of Part-C of Chapter-4) had also made recommendations for up-gradation of pay scalesspecifically for the category/postof Assistant Engineers/Asstt. Directors (H)/ Technical Officers in Engineering Wing of CPWD (under Ministry of Urban Development) from prerevised pay scale of Rs. 6500-200-10500/- to Rs. 7450-225-11500/- effective from 1st January, 2006.
- (xv) That by way of implementation of directions/decisions elaborated in foregoing paras and as per spirit of the 6th CPC Report/Recommendations, the category/post of Assistant Administrative Officers (Erstwhile Office Superintendents Grade-I), Assistant Director (OL), Assistant Engineers (Civil & Electrical), Assistant Directors (H) and Technical Officers in CPWDhad come at par/equal for the purpose of classification, pay fixation& paymentof arrears/allowances in the Grade Pay of Rs. 4600/- in PB-2 since 01-01-2006.
- (xvi) That it will be out of place tomention here that in terms of recommendations of 6th CPC Report (Section-II of Part-C)Directorate General, CPWD vide O.M. No. 6/7/2010-EC IV(SC) dated 06-05-2010 and O.M. No. 8/52/2011-EC.III dated 10/03/2017have extended the minimum benefits of fixation of pay in the pre-revised pay scale of Rs. 7450-11500 (Multiplication of 7450x1.86=13860) along-with benefits ofbunching w.e.f. 1-1-2006 to the category of Assistant Directors (OL) and Assistant Engineers (Civil & Electrical) respectively by ignoring the other similarly placed categories/cadres including the Officers(Erstwhile Administrative Assistant category/post Superintendents Grade-I) in CPWD, who were/are supposed not to be influential. This explicitly reflects and provesmal-functioning, harassment, discrimination, stepmotherly treatmentas well as deprival of their legitimate rights, specifically to the retirees in yourgoodself Sir's regime.

In the last but not least, keeping in view of the facts and circumstances explained in the foregoing paras, it is again requested and strongly demanded that necessary& appropriate orders for granting/extending bunching benefits and fixation of pay on the extant pattern of Master Craftsman, Assistant Directors (OL)

and Assistant Engineers (Civil/Electrical) to the category/post of Assistant Administrative Officers (Erstwhile Office Superintendents Grade-I) along-with undersigned w.e.f. 01-01-2006 may kindly be got finalized at the earliest, so that theunder-signed along with other retirees/officials may gettheir legitimate rights/benefits as per recommendations made in the 6th CPC Report/Recommendations and subsequent amendments/decisions taken by the Government of India (Ministry of Finance) from time to time, failing which there are possibilities to cropping up so many un-necessary litigations.

An early action in the matter is highly solicited.
