With reference to above cited subject, It is brought to your kind notice that the mandatory training of Office Superintendents for promotion to the post of Assistant Administrative Officers, and Upper Division Clerks for promotion to the post of Office Superintendents were delayed last year due to non providing of list of eligible candidates to training institute timely, the same were provided after intervention of this association which resulted delay in promotion to the post of Office Superintendents as well as loss of seniority at all India level to the individuals.

Considering the hardships faced by the ministerial cadre and to avoid un-necessary litigation for seniority and promotion matters, this Association pursued the matter of timely conducting of Mandatory Training with appropriate authority in the beginning of the current year, but it is regret to point out that we have been informed telephonically by the regional training institute, R. K. Puram that they are still awaiting the list of eligible candidates from the Coordination(NR) for finalization of the mandatory training program and your office was also requested telephonically one week ago to provide the list to the training institute at the earliest.

Keeping in view of the circumstances explained above and severe delay on promotion cases of ministerial cadre, it is once again requested that the required list of eligible candidates, may please be provided to the Regional Training Institute (NR), R.K.Puram, New Delhi without further delay.
