#### Respected Sir,

With reference to above cited subject, the office Superintendents posted in Northern Region were transferred vide DDG(Coord.)NR vide office order No. 133/2018 issued vide No. 21(4)/2018/DDG(Coord.)NR /Civil-1/OS/3965 dated 13-11-2018 for which no objection was raised by this association and accepted the same, but we have come to know from the members of this association that some members submitted their requests on the following grounds:-

- 1. For change of office due to convenience to reach office and the vacancies available at the station.
- 2. retention at the same station due to vacant posts are available at the station so that change of station and extra expenditure on exchequer of the Government could be avoided.
- 3. And some members are under consideration for promotion to the post of AAO against the vacancies for the year 2018 which are badly delayed by the Directorate in spite of repeated requests made by this Association at every level in the Department and even the matter of delay in promotions was discussed in the meeting held with Hon'ble MoHUA on 19-03-2018 wherein the then DG and SDG(NR) assured that all the vacant posts of Ministerial Cadre will be filled by promotion within one month time but your are well aware of the present position of vacant posts of ministerial cadre in the Department.

It is also pertinent to mention here that due to delay in promotion most of the OS and UDCs have lost the opportunity to get the level-7 under MACP Scheme.

We have come to know that the transferred Office Superintendents have been relived by the DDG(Coord.)NR on 03-01-2019 vide their office order No. 21(4)/2018/DDG(Coord.)/ NR/C-1/OS/2018-19 dated 03-01-2018 without considering the requests made by the officials which is an arbitrary decision, severity and against the natural justice.

- 1. The representation made by the individual with reference to the order passed by the competent authority neither been accepted nor rejected and the orders are enforced and binding to the individual is against the fundamental rights of representation against the order passed by the competent authority.
- 2. The post of Office Superintendent in the department is a non sensitive post and if another post is available at the station then no need to transfer the individual to other station to avoid the hardship being faced by the individual including extra exchequer liability on account of two time TA on the Government should be avoided for betterment of the nation and the employees.
- 3. some members are under consideration for promotion to the post of AAO against the vacancies for the year 2018 and we are expecting promotion orders in this month as per discussion held with DDG(HQ) therefore concerned official made the request for retention up to 31-03-2019 to avoid another transfer including extra exchequer liability on government and transfer of GPF due to change of PAO.

Since the action already been initiated and implemented through PIMS is unjustified, this association condemns the arbitrary decision, severity which is against the natural justice even not in the welfare of employees and government. However, we request your good self to consider the representations of individual employees and grant a relief by modification of the orders to avoid change of station if another vacant posts are available at the station.
