#### Respected Sir,

With reference to above cited subject and this association letter No: GBCPWDOSAAI/65 Dated 15-10-2020 for which discussion held in the meeting with your good self on 16-10-2020 wherein it has been reported that the official posted in the southern region has not been given mandatory training and they are now under consideration for promotion.

In this connection one more case has been reported to the Association from the Western region who also needs mandatory training, resulting the persons under consideration for promotion but they do not fulfil the essential requirements for the promotion due to not conducting the mandatory training in time by the regions in spite of request made by the concerned.

In view of the above circumstances and to avoid delay in promotion process as well as to protect the legitimate rights of the officials, this Association request your good self to direct Additional Director General (Trg.), National CPWD Academy to Conduct an online mandatory training for Office Superintendents posted in all regions immediately on one time basis and the office superintendents who are due for promotions up to December 2022 but not given training so far may be given the opportunity to participate in the mandatory training online so that promotion process can be carried without any hindrance.
