Respected Sir,

With reference to the above cited subject and reference, the readiness list in respect of Assistant Administrative Officers have been circulated through web site with the direction that the AAOs covered under the readiness list may forward their options to the Directorate through proper channel for transfer/posting by giving names of three stations/ offices in order of preference for consideration, but no list of Stations have been circulated for preferring options for posting, therefore this association is receiving lot of queries from the members of the Association.

We would like to draw your kind attention towards this Association letter of even No. 11 dated 2-04-2019, wherein it was stated that the Directorate's OM No. 10/10/2018-S&D/106 dated 25-03-2019 vide which the organizational restructuring of the department was conveyed with the directions to implement but the status of some cadres including Ministerial Cadre is not clear and it will affect the major changes in the functioning of the department including large number of transfers in every cadre.

The post of AE(Admn) re-introduced where as the post of Assistant Administrative officer is available for administrative purposes therefore it was requested that the proposed post of AE(Admin.) may be utilized for the purpose of Engineering needs of the Department by modification of the structure, and this Association as well as all service Association may be give an opportunity to offer their comments/ inputs/suggestions related to their cadre on account of implementation of the new setup and to dissolve the confusion, anxiety and uncertainty amongst the staff.


