Respected Sir,

Kindly refer the above mentioned subject and to state that the promotion of UDC to Office Superintendent (Seniority Quota) is badly delayed especially in Northern Region. The Association had taken up this matter at all levels in the past 2 years and vacancies of ministerial cadre were intimated to concerned authorities regularly but no fruitful result is received so far.

Recently, our Department proudly declared that within 8-9 years of service, Junior Engineers were given promotion to the post of Assistant Engineer. We are very glad to hear such positive things which shows the department's employee-friendly approach, at the same time, very sorry to state that the ministerial staff are retiring without getting their legitimate right of promotion which shows the apathy of the department towards Ministerial Cadre.

After continuous persuasion, in Directorate and Coordination(NR) the DPC meeting for the promotion to the post of OS in northern region was conducted on 13.3.2019 and the case was sent to the Directorate for approval of the competent authority i.e. DG,CPWD, since then the file is shuttling between Directorate and DDG(Coord)(NR) for one or other reason.

We have came to know that the latest objection is the vacancy for the period 2012-13 is to be verified by the Liaison officer. Even after 7 months of DPC, the promotion orders are not issued so far for the reasons best known to the department. It is very unfortunate that after putting 30-35 years service, officials are retiring without promotion and also those who get the promotion are deprived the all India level seniority for next promotion as promotion orders are not being issued with retrospective effect i.e. as per vacancy period.

Under the given situation, there is unrest among the ministerial cadre which will definitely affect the efficiency and morale of the affected employees. Now there is clear cut vacancy status of the office superintendents available after the restructuring and allocation of posts promotion orders can be issued without any hurdle.

It is, therefore, requested your good self to intervene in the matter and direct the concerned office to issue promotion orders of UDC to OS without further delay.
