Sub: Posting/Transfer in the grade of Assistant Administrative Officer, Technical Officer, Assistant (AD) and Chief Estimator (C/E) – Option for further posting on restructuring of CPWD – regarding.

Respected Sir,

This is with reference to the Directorate's OM No. 23/09/2019-EC-V dated 08-05-2019, options are being invited from the Assistant Administrative Officers and other cadres Who have become due for transfer or will become due for transfer due to revised organizational structure of CPWD issued vide Directorate memorandum No 10/10/2018/D&D/106 dated 25-03-2019.

We would like to draw your kind attention towards this Association letter No. GBCPWDOSAAI/11 dated 02-04-2019 with reference to Directorate's OM No. 10/10/2018-S&D/106 dated 25-03-2019 vide which the organizational restructuring of the department is conveyed for which we offered our comments that, "it is observed that the decision taken in this regard is without consulting the recognized Associations, even the status of some cadres including Ministerial Cadre are not clear and it will affect the major changes in the functioning of the department including large number of transfers in every cadre.

We also stated that the post of AE(HQ) was created in 1996 which was replaced with the post of EE(HQ), this Association raised a demand of up-gradation of post of Assistant Administrative officer to the post of Administrative Officers in the Zonal and above offices at the time of representation to 7th CPC which was recommended by the Department also, with justification of the post we demanded by replacement of post of Executive Engineer(HQ) from Zonal and above offices. In this connection the matter was discussed in several meetings held with JS(W)MoUD, resulting the post of EE(HQ) was removed from most of the Zones in organizational set-up of CPWD vide Directorate vide OM No. 3/4/2015-S&D/Set-up/407 dated 12-06-2015 except 34 posts for which this Association demanding the post of AO instead of EE(HQ).

In present organizational structure, the post of AE(Admn.) is re-introduced where as the post of Assistant Administrative officer is available for administrative purposes therefore proposed post of AE(Admin.) may be utilized for the purpose of Engineering needs of the Department by modifying the proposed structure.

Besides this, we feel that the present organizational structure created many confusion and uncertainty amongst the staff of every cadre.

Therefore, it was also requested that this Association as well as all other service Associations may be given an opportunity to offer their comments/inputs/suggestions related to their cadre for implementation of the new setup and to dissolve the confusion and uncertainty amongst the staff.

It is regretted to point out that neither any meeting on the issue is conveyed so far nor any structure of ministerial cadre has been issued by the Directorate, even no reply/clarification has been given to this Association, In the O.M. dated 08-05-2019, it is stated that **"Who have become due for transfer or will become due for transfer due"** indicates that the allocation in respect of ministerial cadre is not so far been finalized for posting as new offices located at various stations as per proposed re-structuring and status of existing sanction strength is still unchanged, therefore, Directorate itself is not clear about the transfers of employees and asking for options for posting whereas no station has been mentioned in the letter, even it appears that the said OM is also issued without prior approval of competent authority.

Similarly the options have also been invited with reference to readiness list of AAOs issued vide Directorate Office Order No. 8/2/2019-EC.IV (SC)/358 dated 3-4-2019 for which it has been stated vide this Association letter No. GBCPWDOSA AI/14 dated 18-04-2019 that the AAOs covered under the readiness list may forward their options to the Directorate through proper channel for transfer/posting by giving names of three stations/ offices in order of preference for consideration, but no list of Stations have been circulated for preferring options for posting, therefore this association is receiving lot of queries from the members of the Association.
