Sub: Pending Promotions to various posts of Ministerial Cadre resulting Deprival of the Legitimate right to eligible staff - regarding.

Respected Sir,

With reference to above cited subject, kindly refer this Association letter No.GBCPWDOSAAI/109 dated 29-10-2018 and GBCPWDOSAAI/4 dated 14-01-2019 which are self explanatory, addressed to your good self with copy to Hon'ble Minister of HUA and all SDG's with details of vacant posts of ministerial cadre in all regions for taking necessary action.

We would like to refer minutes of meeting held with Joint Secretary (W&H) MoUD issued vide Memorandum No. 752658/JS(W&H)/2016/EW-II dated 13th May, 2016 the DDG(HQ)from Directorate and DDG(Coord.)(NR) were present.

We would also like to recall the discussion held in the meeting with Hon'ble Minister Of Housing and Urban Affairs on 16th March 2018 on the various issues related to ministerial Cadre wherein the issue of promotions of Ministerial Cadre was also discussed in detail and it has been assured by the then Director General, SDG(NR) and ADG(S&P) who were present in the meeting that the promotion orders likely to be issued in coming fifteen days. In this connection some suitable directions were also suggested by the Hon'ble Minister of Housing and Urban Affairs for filling up all the vacant post within one month time.

Now, we are enclosing the statement of vacant posts of ministerial cadre in all regions as on 1-3-2019, 1-5-2019 and 1-7-2019 as per the data available in the PIMS(excluding the sanctioned strength of Border Fencing Region) which shows that the vacancies of ministerial cadre are increasing day-by-day and eligible candidates are still waiting for the promotion to the next grade as AAO/OS/UDCs, the promotion orders to the post of office superintendent to Assistant Administrative Office for the vacancy year 2018 is still pending. The vacancy position to the post of Office Superintendents/UDCs in the Northern Region is more than 40% and 38% respectively.

Through department web site, we have come to know that the matter of promotion of ministerial cadre was taken as agenda in video conference many times, but no fruitful results come out, therefore ministerial cadre feeling deprived from their legitimate rights and the continuous shortage of staff is also hampering the spirit of work.

Under this pressing situation, we feel that your good self will try to understand the agony of the ministerial cadre and will issue the suitable directions to concerned officers for filling up the all promotional post by issue of promotion orders without further delay.
