Sub: Transfer and posting in respect of Assistant Administrative Officers and Office Superintendents – reg.

Revered Sir,

With reference to above cited subject, it has been observed since last six months that the ministerial cadre staff have been transferred from one station to another station even after vacancies are available at the present station, we also observed that the female staff have been targeted and their genuine grievances and medical conditions have not been considered sympathetically. We are receiving many such complaints from all regions and some ministerial cadre staff is now planning for voluntary retirement. For example, Smt. Renu Taneja OS of Northern Region has already applied for voluntary retirement because her family conditions does not allow her to shift from the present station and she has been not been given near stations and transferred to far off which compelled her to opt voluntary retirement.

Recently, we have received an application from Smt. N. Vijayalakshmi, OS of Western Region which is enclosed herewith for your kind perusal and issue of suitable directions to the concerned authorities. We also come to know from ministerial staff that their TTA bills are also pending due to non availability of funds, if funds are not available in TA head, why the staff is being transferred from one station to another station in spite of available vacancies at the present station.

We would like to make it clear that this association is not opposing the transfer of staff from one office to other after completion of their tenure mentioned in CVC guidelines and transfer policy, but we request that the change of station should be minimum and genuine and medical grounds also be considered sympathetically keeping in view of the healthy working conditions and growth of the department.

We are hoping a positive response in the matter.
