**Sub: Transfer and Posting of Group 'B' and 'C' officers and staff in
CPWD - regarding.**

Respected Sir,

With reference to above cited subject and Directorate's OM No. 10/10/2019-S&D/545 dated 26-11-2019 wherein it has been decided that the transfer and posting of Group 'B' and 'C' staff earlier being done at Directorate level will now be undertaken by respective regional Coordination Units.

In this connection this Association received many calls from the members of the Association regarding many apprehensions and difficulties in implementing these orders.

Keeping in view of the doubts/apprehensions of the staff, we have requested the then Director General, CPWD vide letter No. GBCPWDOSAAI/29 dated 27-11-2019 for a brief discussion in the matter before the implementation of the said order in respect of the solutions for the difficulties which would be faced by the staff after implementation of the order under reference.

But no meeting was given and Directorate, CPWD issued a draft inter regional Transfer Guidelines in respect of AAO., ASO, SO(Hort.), PS(Subordinate Cadre), Steno Grade-I, & Technical Officer, Assistant (AD) vide OM No. 5/4/2019-S&D/19 dated 07/01/2020. At this point, this association vide letter No. GBCPWDOSA/36 dated 17-01-2019 addressed to Director(S&D), submitted a detailed note describing difficulties faced by the ministerial cadre and also administrative violation of rules which will attract unnecessary litigation. In addition, comments on inter region policy was also submitted vide the above mentioned letter.

It has been observed that transfer policy in respect of Assistant Administrative officers are still under consideration in the Directorate whereas transfer/posting orders are being issued by the respective SDGs and our staff working under pressure as uncertainty prevail.


