Sub: Calling of options for posting /transfer in the grade of Assistant Administrative Officers – options for further posting on restructuring of CPWD- reg.

Ref: Your office OM No. 9(1)(3)//CE(Works cum TLQA)/2019/614 dated, 16/12/2019.

Respected Sir,

With reference to above cited subject and reference, it is very surprising that the option of Assistant Administrative officers posted under southern region have been invited for further posting keeping in view of restructuring of CPWD. It has also been observed that the region office is keen to transfer the officers without completing the station tenure keeping in view of exigencies of work.

In this connection we would like to mention that 6 No of newly promoted AAO has already been allocated to Southern region for further posting vide Directorate OM No. 5/42/2018-EC.IV(SC)/890 dated 17/12/2019, it is also intimated that this Association regularly pursuing the matter of promotion of ministerial cadre with the Directorate and all regions since 2013, but large number ministerial cadre posts are lying vacant in every region including 30 vacancies of AAO for the vacancy year 2019 are still lying vacant for which matter has already been taken up with Directorate for issue of promotion orders.

We would also like to mention here that as per restructuring of CPWD only those employees whose existing office has been closed or renamed or the sanctioned strength has been changed could be transferred to other office, as per para 12.5 (iii) of CPWD manual of regular establishment and office procedure the longest stayee list shall be circulated by January/February of the year. The list shall be prepared based on completion of station tenure as on 30th June of the year. The transfer orders should be issued in the month of March/April so that the officers can move before commencement of the academic year.
