**Sub:** Promotion on regular basis of Office Superintendents to the post of AAO in respect of the vacancy year-2018 - Uploading ACC/APAR/Training Status in PIMS portal – Reg.

Respected Sir,

Reference is invited to Directorate General Office Memorandum No. 5/42/2018-EC.IV(SC) dated 09/04/2019, whereby Administrative Clearance, status of training and APARs of 16 Office Superintendents have been called for promotion to the post of AAO for vacancy year 2018.

In this connection kindly refer Directorate's Office Order No. 102 of 2018 issued vide No. 5/41/2017-EC.IV(SC) dated 14/08/2018, even No. dated 12/09/2018, even No. dated 17/10/2018 and even No. 30/11/2018, whereby the Office Superintendents whose details are called for vide O.M. dated 09/04/2019 have been debarred for promotion for one year (except Sh. Rajiv Kr. Talwar) as they were considered for promotion for the vacancy year 2017-18. As per DOPT instructions, once a person is debarred for promotion he can be considered for promotion only after leaving one vacancy year i.e. those considered for promotion during 2017-18 can be next considered only for the vacancy year 2019-2020.

The Directorate is delaying in issuing promotion orders to the post of Assistant Administrative Officer and the panel for vacancy year 2017-18 which should have been exhausted by way of promotions by 31/03/2018, the first orders are issued on 14/08/2018. Although it may seem proper that on debarring a person on 14/08/2018, he/she can be promoted after 14/08/2019, but actually promotion orders for the vacancy year 2018 or 2018-19 have not been issued till date. Further it is pertinent to mention here that those who forgo their promotion are senior most, so when they are considered next time their names will appear on the top in the panel. The eligible candidates (in seniority list after forgone persons) are losing their opportunity for promotion, first by the delay in issuing panel and then by not following prescribed instructions of the Government of India, by the Directorate

If a person forgoes his/her promotion in a particular year, his/her details are already available with the Directorate; but when he/she is again considered the same details are once again called for whereas only the latest APARs would be required by the Directorate for completing the documents/formalities.

It is therefore requested that the above matter may kindly be reviewed as per existing instructions and O.M. dated 09/04/2019 be withdrawn. Also immediate action be taken for promotion of OS for the vacancy year 2018 and 2019.
