Sub: Posting of Ministerial staff to their family/choice station in view of unprecedented pandemic COVID-19 -- sympathetic consideration reg.

Ref: Our earlier letter even No. 17 dated 01.04.2021

Most Revered Sir,

I would like to bring your kind attention to above referred letter (copy enclosed for ready reference) in which we have urged to extend the stay on rotational transfers granted by MoHU&A last year, for one more year, in view of the one of the extremely hard time being faced by the humanity since its existence. It was also requested that the staff/officers who have already completed their station tenures and other staff who are yet to complete their station tenure but have submitted their representations for transfer to their family / choice stations may please be transferred at the earliest.

Directorate, CPWD had already taken a lenient and much welcomed view regarding transfer and posting of Executive Engineers vide O/o No. 4 of 2021 issued vide No.28/8/2020-EC.I(B) dated 20/01/2021. By this order, a lot of Executive Engineers have been transferred before completion of their tenure without TA, DA and joining time to their choice/family stations.

It is requested that the same approach may please be taken in respect of ministerial staff who have been posted to a station other than their family station and thereby leaving their family behind devoid of care as Head of family. On the other hand, the official himself is facing the grave situation all alone in un-hospitable conditions in a city with thousands of people living but none to take care of him, if he, GOD forbid, becomes CORONA positive.

With heavy heart, we would like to apprise of an unfortunate incident of the demise of Sh. D.S. Barma, AE(Civil) in Bhopal who was staying all alone far away from his family. He lost his life to Corona in an alien city, in the absence of any family member to take care of his health. The most aghast and heinous situation is that he was lying at the door of a hospital for hours, but nobody was there to get him admitted in the hospital.(Copy of news and twitter is attached)

Another drastic incident too occurred at Bhopal where Sh. Hemraj Hiralal Hedao, Office Superintendent, who was posted at DD(H),Bhopal-I expired on 14-04-2021 at Bhopal due to Corona and non availability of oxygen in Hospital. His wife too expired on the same day due to Corona in Bhopal leaving behind two of their children all alone and on their own.

This is the hardest and testing times which we are facing in our lifetime. The positivity rate of patients being tested for COVID-19 has surpassed 36% in Delhi and it is almost same in all over the country. Hospitals are overflowing with patients; hospitals beds are in scarcity and the most dreadful of all is that the oxygen supply is far below the present demand. In such a horrific time, many of our ministerial staff is posted to a station away from their family station. In many cases their family is also without the support of any male member, as the lone male member of the family is far away from their place of residence. This is a strange concoction of situation leading them to extreme psychological problems amalgamated with depression and trauma.

It is our humble request to your good self to please issue strict directions to the concerned authorities for transferring officials to their place of choice, keeping aside all the guidelines, exigencies of works etc., as this is a time where remain alive is the biggest task of the humans and one can achieve this only with his near and dear ones. Once, this pandemic is over the transfer and posting policy will be welcomed whole heartedly by everyone.



इलाज के लिए कोरोना पीड़ित आधा घंटे अस्पताल के बाहर सड़क पर पड़ा रहा नवदुनिया द्वारा जानकारी देने के बाद प्रशासन ने कराया भर्ती

भोपाल (नवदुनिया प्रतिनिधि)। कोरोना काल ऐसी तस्वीरें दिखाएगा, कभी सोचा न था। मामला राजधानी के सुभाष नगर रेलवे फाटक के सामने खुले आयुष्मान हाई टेक अस्पताल का है। यहां कोरोना संक्रमित एक मरीज आधा घंटा सड़क पर पड़ा रहा, लेकिन वहां मौजूद अस्पताल प्रबंधन ने उसे भर्ती नहीं किया। यह हाल तब है, जब मरीज की विभिन्न जांचों की रिपोर्ट पहले ही डॉक्टर को दिखा दी गई थी।

दरअसल, केंद्रीय लोक निर्माण विभाग में सिविल इंजीनियर पद पर काम करने वाले दयासागर वर्मा कुछ दिन पहले संक्रमित हो गए थे। वे यहां अकेले रहना नगर में किराए पर रहते हैं। उनके मकान मालिक सुशील पंडित ने एक-दो अस्पताल में इलाज के लिए बात की, लेकिन बिस्तर नहीं मिला। सुशील पंडित ने बताया कि सुभाष नगर में नए खुले अस्पताल आयुष्मान हाई टेक में बात की तो डॉक्टर ने पहले रिपोर्ट मांगी। इस बीच विभाग के उनके अप्पसरो से बात कर इलाज के खर्च की बात की। इलाज के लिए पैसा मंजूर होने के बाद अस्पताल में रिपोर्ट दिखाई और प्रबंधन ने मरीज को लाने को कहा। चूंकि दयासागर कोरोना संक्रमित थे इसलिए हम उनके साथ नहीं

जा सके लेकिन प्राइवेट कैब कर उन्हें अस्पताल भेज दिया। कैब ने अस्पताल के बाहर दयासागर को छोड़ दिया लेकिन दयासागर की हालत बहुत खराब थी और उनसे चलते भी नहीं बन रहा था। इस पर वो अस्पताल के सामने सड़क पर ही लेट गए और आधे घंटे तक वो सड़क पर ही पड़े रहे। इस बीच उनके मकान मालिक ने अस्पताल फोन पर बताया भी कि मरीज पहुंच गया है लेकिन अस्पताल प्रबंधन ने उसे भर्ती नहीं किया। इस दौरान वहां मौजूद दो पुलिस जवान भी अस्पताल से मरीज को भर्ती करने का कहते रहे।

वाद में नवदुनिया द्वारा एसडीएम को जानकारी दी गई, जिसके बाद मरीज को अस्पताल प्रबंधन ने अंदर किया व ऑक्सीजन लगाई। अस्पताल की इस लापरवाही को लेकर जब वहां के डॉ. यशवीर सिंह से बात की गई तो उनका तर्क था कि हमें नहीं पता था कि जिस मरीज को भर्ती करने के लिए हमसे बात की गई है, वो वही हैं। उन्हें सड़क पर बाहर लेटा देख हमने वहां मौजूद पुलिसकर्मियों को बताया। हमारे अस्पताल में कोई बिस्तर खाली नहीं था, इसलिए हम किसी को भी उठाकर भर्ती नहीं कर सकते।

Respected Sir,

We would like to draw your kind attention on the reference and subject cited above by which relief on rotational transfer upto 30th April-2021 was granted to the officers and staff posted in CPWD keeping in view of the Covid-19 pandemic causing serious disruptions in the country except the exigencies of work/Promotions/Compassionate grounds / and specific approval of the Ministry.

The ministry has taken a lenient view to avoid any unhealthy condition/ compelling circumstances and safeguard the officers and staff but the department-side has not paid any attention towards the ministerial cadre staff already completed station tenure and seeking transfer to their home station as the ministry's OM was silent on the issue whereas Engineering cadre was given opportunity to opt the station and they have been transferred even without completing the station tenure also.

The pandemic situation is still existing and increasing day by day. As per the news published in various news papers, coming days could be very crucial/critical, but our department is very keen to issue the rotational transfers and already issued the readiness lists of Assistant Administrative Officers and Office Superintendents and options are called for issue of transfer orders even for the non sensitive posts. Besides this, it is also come to the notice of this Association that the transfer TA bills are pending in various offices since more than one year due to non availability of funds.
