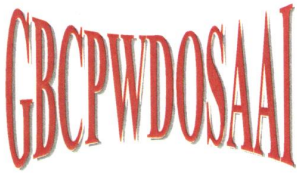
We request your personal intervention in the matter to resolve this issue, as the matter is already badly delayed.
