Sub:- One-time relaxation on Compassionate Appointment in view
of present COVID-19 pandemic-reg.

Respected Sir,

As you are aware, the present COVID-19 pandemic has wreaked havoc all over world and our Central Public Works Department is no exception. Many of our officers and officials across all groups and Cadre have lost their life while performing duties as during the current lock down period all the Central government offices are working with at least 50% attendance.

CPWD Officials are regularly attending their respective offices to keep the government afloat even in this pandemic time. They have to work in various hospitals including COVID dedicated hospitals, various ongoing construction projects like Central Vista, AIIMS, IIM, IIT etc. which are of very prestigious nature and time bound also. While performing their duties many of our colleagues have contracted Corona and some of them have lost their lives also. In one of the cases, both husband and wife lost their lives which were very shocking and painful.

We would like to refer the letter of Central Board of Direct Taxes, Department of Revenue, Government of India wherein immediate remedial measures have been initiated regarding appointment of dependant family members of officers/officials under existing Compassionate Appointment Scheme (copy enclosed). Besides this it is also seen from the news papers that various States have taken steps for Compassionate Appointment to the dependents of the deceased officers who have sacrificed their life while performing their duties in the pandemic situations including huge ex-gratia payments also declared to their families as an immediate relief.

Subject: Appointment of dependent family members of officers/officials under the existing Compassionate Appointment Scheme – reg. -

Kindly refer to the subject cited above.

2. The Covid-19 pandemic has wreaked havoc since it raised its head in India and unfortunately many officers and officials of the Department have lost their lives while in service due to this disease. The situation is even more painful where the officer/official happened to be the sole bread earner in the family. The entire Income-tax fraternity stands in solidarity with the families of the deceased employees.

3. In this context, it is stated that the DoPT vide O.M. No. 14014/6/94-Estt(D) dated 09.10.1988 had issued the 'Compassionate Appointment under Central Government' Scheme to grant appointment on compassionate grounds to a dependent family member of a Government servant dying in harness or who is retired on medical grounds. The Scheme has been updated from time to time. The main object of the Scheme is to relieve the families of such Government servants from financial destitution and to help them get over the emergency.

4. Vide letter dated 4th May 2021, Chairman, CBDT had directed for immediate processing of Death/ Retirement benefits/ family pension papers in all cases of unfortunate demise of any officer/ staff of the Department. I am further directed to state that in all such cases the family members of the deceased employees may also be advised about the provisions of the Compassionate Appointment Scheme and assisted in filing application for appointment under the Scheme at the earliest. The applications so filed may be disposed expeditiously and the Directorate of HRD may be contacted on any issue which may enable expeditious disposal of the applications made by family members of the deceased employees under this Scheme or for any further suggestions in respect of the Scheme.

5. This issues with the approval of the Competent Authority.
