Sub: Restarting the process of Rotational transfer of Officers/Staff.

Ref: Directorate OM NO. 8/3/2021-EC.IV(SC)/186 dated 24/02/2021.

Sir,

Kindly refer Directorate's O. M on the subject in which all SDGs/Coordination Units and Cadre managing Sections/ Divisions/ Organization in CPWD Headquarter in New Delhi are requested to initiate preparing consolidated data requiring to issue posting orders etc. in advance so that each unit must be ready to issue transfer orders within short time whenever a decision is taken by MoHUA/Directorate to restart the rotational transfers.

In this connection, we would like to draw your kind attention on the data obtained through RTI from e-governance and as per the information provided on 07-01-2021, which shows that 1147 officers/staff have been relieved from their present office on transfer but not joined the new office, besides this, more Officers/staff transferred from their present office but not relieved due to ban imposed on transfers due to Covid-19.

Secondly, large number of ministerial cadre posts of CPWD are lying vacant due to delay in promotion process and it has been observed in previous orders that the persons have been transferred on rotational transfer many times but they were not joined and enjoying same station posting continuously, even they forgo their promotions because they have already got the promotional benefits through MACP whereas it is a punishment to the persons who accept the promotion in time and also accept the transfer in due time.

We are once again submitting details of vacant posts of ministerial cadre as under:-

It is also brought to your kind notice that the large number of transfer orders were issued during 2019-20 but the transfer TA bills have not so far been paid to large number of staff due to non availability of funds resulting hardships to the individuals in corona pandemic situation which is still exists and increasing in some states day by day.

Keep in view of the above circumstances we request your good self to minimize change of station while making rotational transfers and following suggestion are submitted for consideration please :-

1. To take necessary action for implementation of transfer orders already issued and the persons already relieved but not joined.
2. The transfer orders already issued should be implemented on priority.
3. Those persons already completed their station tenure and wants transfer and also request for transfer on medical ground may be considered first for transfer.
4. Fill all the vacant posts by way of issuance of promotion orders.
5. Still needed, rotational transfer order may be issued for sensitive seats and change of station may be kept minimum.
