Respected Sir,

With reference to above subject, it is informed that Sh. Ram Prasad Meena, A.A.O. working in Western Region [Chief Engineer (Gandhinagar) has been transferred to Northern Region vide above referred orders, but without the benefit of TA/DA and Joining Time. For this, the reason given in the order itself is that he has been transferred at his own request.

In this context, it is mentioned that not allowing the benefit of TA/DA to Sh. Ram Prasad Meena, AAO is outrightly unjustified and against all prevailing rules and regulations regarding transfer of employees in CPWD. At present, the rules and regulations for determining Inter Regional Transfer is as under: -

1. DG, CPWD vide OM No. DG/S&D/57 issued vide file No.05/04/2017-S&D/536 dated 11.12.2018(Annexure-B) issued modification in transfer and posting that **the normal period of continuous stay of all officers/officials shall be 3 years at any post as well as any station.**
2. Presently, no Inter Regional Transfer policy for Assistant Administrative officers is in force in the CPWD. However, the post is equivalent to Assistant Engineers and hence, IRT guidelines issued for Assistant Engineers may be mutatis mutandis apply to the AAOs.

Here, it is intimated that AAOs and AEs are being posted at any place in India at the time of their promotion to these posts. However, to make out the imbalances of vacancies among Regions, Directorate issues Inter Regional Transfers in the cadre of Assistant Engineers. For the last 4 to 5 years, the Directorate has not issued any annual IRT in the cadre of AEs also as the vacancies are being filled up regularly at the time of promotions.

3. Guidelines for Inter-Regional Transfer/Posting of Assistant Engineer in CPWD is issued by Directorate General, CPWD vide OM No. 18/01/2008-EC.III dated 19/05/2014 (Annexure-C). Para 2.2, of this OM, which fixes the tenure during IRT posting, is reproduced here under for your kind consideration: -

*The tenure of stay in hard area shall be 2 years and 3 years in other areas in case of Inter-Regional Transfer. Period of leave, training etc., in excess of 30 days per year will be excluded in counting the tenure period. However, the period may be extended in exceptional cases in exigencies of public service or when the employee concerned is prepared to stay longer. Application for inter-regional transfer on completion of tenure, back to choice region along with certificate of leave availed during the tenure from Controlling Authority shall be accepted 3 months before the successful completion of stipulated tenure. Transfer-order authorizing posting back the Assistant Engineer would be issued well in time. Assistant Engineers shall not be retained by the concerned Chief Engineer under any circumstances except for express order of Additional DG of the region for a period not exceeding three months. AEs who have completed 2 years in a normal area on I.R.T. shall be considered for repatriation (excluding the leave taken more than 30 days in one year) on request except exigencies of work. His transfer benefit shall be governed by the latest version of the OM issued vide F.No.30/28/11-EC.I dated 04/04/2013.*

4. **Sh. Ram Prasad Meena, A.A.O.** has been posted to Western Region since 12/12/2018 (PIMS posting details attached as Annexure-D). Hence, he has completed 4 years and 7 months at the time of issue of his Inter Regional Transfer to Northern Region. Hence, issuing of his IRT orders without TA/DA and joining time is completely unjustified.
5. Even, there are precedents available (copy of DG, CPWD Corrigendum issued vide No.18/02/2015-EC-III dated 01/02/2016 enclosed as Annexure-E) where Inter Regional Transfer orders, which were issued without TA/DA and joining time because the official has not completed his tenure, has been converted in 'Public Interest' transfer, i.e., with all transfer benefits (TA/DA) as the officer has not been relieved timely after issue of IRT resulting in him completing his normal tenure of stay in other region before his relieving.

In continuation of this office O.M. No. 5/4/2017-S&D/398 dated 07.09.2018 and in view of CVC guidelines regarding probity, it has become imperative to review the transfer/posting guidelines mentioned in Chapter 12 of CPWD Regular Establishment and Office Procedure Manual 2013. It has also been observed that the transfer/posting made on the guidelines of Sensitive/ Non- Sensitive posts, Station tenure, Region tenure etc. lead to some over-lapping and administrative difficulties in implementation of transfer/posting orders.

2. In light of the above backgrounds para 12.6 a)(i), b)(i), b)(ii), b)(iv), b)(ix), c)(i), d)(i), e)(ii), e)(iii), e)(x), f)(ii), h)(ii) of Chapter 12 of CPWD Regular Establishment and Office Procedure Manual 2013, stand modified to the following extent:-

**"The normal period of continuous stay of all officers/officials shall be 3 years at any post as well as at any station".**

## OFFICE MEMORANDUM

**Sub: Guidelines for Inter-Regional Transfer/Posting of Assistant Engineers (Civil & Electrical) in CPWD.**

### 1. INTRODUCTION

1.1 In supersession of previous orders issued by this Office vide O.M. of even no. dated 01.04.2010, subsequent corrigendum dated 27.04.2010, OMs dated 31.05.2010, dated 20.08.2010, dated 24.01.2011, dated 11.01.2012, dated 27.02.2012, dated 27.02.2013 and dated 25.09.2013 on Inter- Regional Transfer/posting, modified guidelines are issued as detailed below:

1.2 Inter-Regional transfer/posting of Assistant Engineers (Civil & Electrical) will be under the overall control of the SDG(HQ), Directorate General, CPWD

1.3 The jurisdiction of each region is indicated below:

Spl. DG (NR) & Spl. DG (DR)	Northern Region	Comprises units located in Delhi, Uttar Pradesh, Uttarakhand, Himachal Pradesh, Union Territories of Chandigarh, Rajasthan, Punjab, Haryana and Jammu & Kashmir i/c Indo-Pak Border works.
Spl. DG (ER)	Eastern Region	Comprises units in West Bengal, Bihar, Jharkhand, Orissa, North Eastern states and Sikkim.
Spl. DG (WR)	Western Region	Comprises units in Maharashtra, Gujarat, Madhya Pradesh, Chhatisgarh and Goa, UT of

		Lakshadweep, Dadra and Nagar Haveli, Daman and Diu.
Spl. DG (SR)	Southern Region	Comprises units in Andhra Pradesh, Tamil Nadu, Kerala, Karnataka, Andaman & Nicobar and Puducherry.

1.4 The Inter Regional imbalances of Assistant Engineers shall be worked out once every year so as to determine the necessity and extent of the Inter Regional Transfer to be effected during the year. For working out the imbalances, sanctioned strength and held strength of Assistant Engineers in each region as on 31<sup>st</sup> December shall be intimated to the Directorate General office for working out the regional imbalances for subsequent year.

## 2. GUIDELINES FOR INTER-REGIONAL TRANSFER / POSTING.

2.1 If the inter-regional transfers are necessitated to remove imbalances in the working strength of AEs in the various regions, the same shall be effected as under:-

(i) Any officer whether above or below 50 years of age who voluntarily opts for inter-regional transfer, shall be considered for inter-regional transfer.

(ii) A list of all Assistant Engineers with age less than 50 years as on 1<sup>st</sup> of January of each year shall be prepared and circulated by concerned Executive Engineer (Coordination). The list will include names of all the Assistant Engineers below 50 years of age including those who have returned from hard area or from Inter Regional Transfer within the last 10 years. However, for those who have returned from Hard area / Inter Regional Transfer during the preceding 10 years, the date of return from such posting shall also be indicated. This list will be made public and shall be forwarded to Directorate General on or before 31<sup>st</sup> January of each year. This list of longest stayee Assistant Engineers received in the DG office from EE(Coord.) will be sorted out in the order of seniority based on the length of the stay in the region and will be the basis of inter-regional transfer.



(iii) Assistant Engineers likely to be sent on Inter-regional transfer, may forward their option/choice of three regions in order of preference to the concerned EE(Coord) for onward transmission to Directorate General, CPWD. This option shall reach in the Directorate by 28<sup>th</sup> February of each year. Choice of region would be considered depending upon availability.

(iv) The Junior Engineers who qualify in the Limited Departmental Competitive Examination for promotion to the post of AEs and who are below 50 years of age may be posted outside their regions irrespective of the length of their stay in the region/station. Transfer shall be affected in the order of seniority based on the length of the stay in the region. In case of officers returning from hard area or coming on Inter-regional Transfer from another region, their stay in the region shall be counted from the date of return from the hard area or coming from Inter-regional Transfer from another region respectively.

(v) The Junior Engineers below 50 years of age on the date of issue of promotion order to the grade of Assistant Engineers against seniority quota and whose Region seniority is already covered in the Inter Regional Transfer shall be posted outside the region.

(vi) One year retention may be granted to those officers whose children are studying in Class XII.

(vii) In case of working spouse, the case may be dealt as per DoPT guidelines. Regarding posting of wife and husband who are either the Central Government employees or one of them is State Government employee, the posting of both husband and wife should be given to the nearest stations as far as possible following the DoP&T guidelines. The posting of wife and husband who are both the Central Government or one of them is State Government employee, the posting of both husband wife should be given to the nearest station but not far than distance covered by overnight journey or have maximum distance of 600 Km.

(viii) The order of I.R.T. may be issued once in a year as per guidelines and on administrative ground and in exigencies in public interest Department can also issue I.R.T. orders i.e., on promotion from JE to AE etc.

(ix) The order of Intra-regional transfer shall not be issued before issue of the inter-regional transfer order by the HQ. The AEs whose names are reflected in the readiness list of I.R.T. should not be transferred till the final order of the I.R.T. is issued by the HQ. Even after issue of order of Inter-regional Transfer, Intra regional transfers involving change of station for those AEs who are likely to be transferred under IRT for next year should not be made.

(x) While making inter-regional transfer, station tenure shall not be a parameter for consideration.

(xi) The inter-Regional Transfer would be made through the aforesaid criteria in order of sequence brought out above.

2.2 The tenure of stay in hard area shall be 2 years and 3 years in other areas in case of Inter-Regional Transfer. Period of leave, training etc., in excess of 30 days per year will be excluded in counting the tenure period. However, the period may be extended in exceptional cases in exigencies of public service or when the employee concerned is prepared to stay longer. Application for inter-regional transfer on completion of tenure, back to choice region along with certificate of leave availed during the tenure from Controlling Authority shall be accepted 3 months before the successful completion of stipulated tenure. Transfer-order authorizing posting back the assistant engineers would be issued well in time. Assistant Engineers shall not be retained by concerned Chief Engineer under any circumstances except for express order of additional DG of the region for a period not exceeding three months. AEs who have completed 2 years in normal area on I.R.T. shall be considered for repatriation (excluding the leave taken more than 30 days in one year) on request except exigencies of work. His

transfer benefit shall be governed by the latest version of the O.M. issued vide F. No. 30/28/2011 - EC I dated 4<sup>th</sup> April 2013.

2.3 Completion of stay in Delhi PWD or at any other station/posting will not come in the way of Inter-Regional Transfer if it is due as per these guidelines.

2.4 Period of continuous stay in hard area, Border fencings, Border roads & Flood Lighting work will be 2 years. On successful completion of posting in above areas, Assistant Engineers shall not be posted outside their region for next 10 years.

2.5 The Assistant Engineers who have Completed 50 years of age and ladies shall normally not be posted to hard area or out of the region.

2.6 The order issued under the authority /delegation of power of Directorate General in term of these guidelines shall be binding on all controlling officers, for relieving the transferred officer on Inter-regional Transfer after successful completion of their tenure. However, the Controlling Officers will get their substitutes posted in advance from their Regional Office.

2.7 All Controlling Officer shall initiate preparatory action three months in advance to enable them to relieve Assistant Engineers in time after successful completion of their tenure.

2.8 (i) These inter regional transfer orders issued by the Directorate General shall also serve as an authority to relieve back Assistant Engineers after successful completion of their tenure to the region of their choice. Any retention in the public interest up to 3 months with recorded reasons should be got approved from the concerned ADG under intimation to regional SDG for intra-regional transfer and DG for inter-regional transfer. Case for retention on personal ground shall be sent to hard case committee within 15 days, after issue of transfer orders. The Hard Case Committee has to decide the case within 2 months.

(ii) Hard case Committee will consider all type of cases of retention on medical ground in accordance with existing guidelines and also can make

recommendation considering the merit and exigencies of the cases apart from the guidelines.

2.9 All the transfer order of AEs should be reviewed monthly at the level of Chief Engineer and bimonthly at the level of ADG concerned. Review report for intra-regional transfer and for inter-regional transfer shall be sent to Spl. DG of that region and DG, CPWD respectively by CEs along with mention of detailed reasons for not relieving the transferred AEs.

2.10 Regional Spl. DG can relieve the AEs through PIMS after period of 3 months, if their request for retention is not agreed by the Hard case committee.

2.11 Power to grant 2 retentions (1 year each) for intra regional transfer would be exercised by Spl. DG of the region. For the matter of all inter-regional transfers, power of any retention will rest with DG, CPWD.

2.12 The officers going on Inter Regional Transfer shall be considered for choice place of posting on return from Inter Regional posting.

3. The AEs/their family as per their service record, who are suffering from terminal illness shall be considered for exemption from inter-regional transfer on purely medical grounds on submission of such medical certificate from any competent Government Hospital or hospital approved by CGHS. Similarly AEs having their children mentally retarded / spastic needing special school for their education/training shall normally be allowed retention in the region on request and on submission of medical certificate from any competent Government Hospital or Hospital approved by CGHS provided his retention is duly recommended by his Controlling Officer.

4. Director General(CPWD) shall have full powers to order transfer/posting of AEs(Civil & Electrical) from one region to another or retention of any AE(C & E) keeping in view the exigencies of public service, compassionate grounds, administrative requirement and merits of individual cases, as well as making any changes in these guidelines.

5. Constitution of Inter-regional Transfer/posting committee and Hard case committee shall be as under

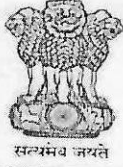
