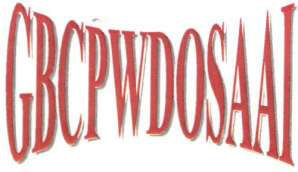
Sub: Regarding granting of Seniority to Office Superintendents of Northern Region with retrospective effect (from the date of vacancy) due to delay of promotion by the Department.

With reference to above cited subject, we would like to refer this Association letter No. GBCPWDOSAAI/67 dated 21-10-2020 and to state that a chronological report with copy of all relevant Correspondence and OM and order in the matter was submitted to your office with reference to decision taken in the meeting held with Special Director General(HQ) on 16-10-2020 and necessary directions in this regard issued by the Directorate vide letter No. 4/4/2020-EC IV (SC)/787 dated 27-11-2020, followed by reminders even No. 82 dated 11-12-2020, 5 dated 05-01-2021 and 13 dated 02-03-2021, but no communication/decision in the matter has so far been issued by your office till date.

We would also recall the discussion held with your good self in meeting held on 12-01-2021 in your chamber in this regard in detail and Keeping in view of the sensitivity of the matter, this Association regularly requesting your good self to examine the matter and allow proper seniority to the Office Superintendents i.e with retrospective effect and terminal benefits from the actual date of resuming the charge **to remove the anomaly, discrimination, litigation as this case is clear-cut violation of fundamental right of equality under Article-14 of constitution of India as the seniority already allowed to Assistant Engineers, UDCs earlier by the Directorate and Coordination (NR).**
