Revered Sir,

With reference to above cited subject, you are aware that this association is regularly demanding for completion and uploading of APARs on CPWD Web site, as non-completion of APAR is the main cause of delay in promotions. It is regret to mention here that being the General Secretary of the Association an information regarding position of writing/uploading of APAR in respect of AAO and OS was sought through RTI Act-2005 vide application dated 27-01-2016. In this regard a detail report was also sent to DG, CPWD with a copy to all Spl. DGs and your goods self vide letter even No. 67 dated 18-04-2016 for information and taking necessary action. In the referred letter it was also reiterated that and if the APARs are timely written and reviewed by the concerned authority, it is responsibility of the custodian to upload the APAR on Web site, in compliance of provisions of Section 4 of RTI Act.-2005 which is an obligation on part of public authorities. In case, if the APAR has not been written as per the stipulated schedule, it is a violation of CVC guidelines, and has to be dealt accordingly.
