4. Decision of Reporting Officer/Review officer in respect of AAO posted in Circle office.
5. Non-filling of vacancies of AAO.
6. Non-filling of vacancies of OS in all regions resulting stagnation.
7. Timely Completion and Uploading of APAR in respect of AAO/OS.
8. Regarding delay in promotion of AAO due to mandatory training of OS.
9. Reimbursement of Telephone charges
10. Functioning of AAOs in Directorate, Regions and Zonal offices in respect of Directorate OM No.22/2/2016-EC-IV(MC) dated 30th August 2016.
11. Filling the vacant posts of Section Officers.
12. Implementation of transfer orders and pick and choose method adopted for transfer and posting of AAO/OS.
