Sir, we are thankful that the we have been heard in person and important issues were discussed in detail and decisions were taken but it is regret to point out that no minutes of the said meeting was issued so far which it self destruct the purpose of the meeting as well as clear violation of the instructions issued vide Directorate OM No. 43/1/2016-General Dated 13th April, 2016. However the discussion held in the said meeting and decisions were taken has already been conveyed by the Association vide letter of even No. 93 Dated 22-06-2016 .


We, once again pray your good self to kindly intervene in the matter for implementation of the decisions taken in the said meeting and conveying the status of our demand so that we can take further course of action.
