Sub: Non implementation of transfer orders in respect of Assistant Administrative Officer and Office Superintendent.- reg.

With reference to above cited subject, it has been observed that the when a AAO seeking transfer on the basis of personal circumstances and is also prepared for forgiving his/her, TA/DA/Joining Time. Transfer orders, for these candidates are being issued after getting approvals from the hard case committee, with the instructions that he/she may be relieved immediately by making internal arrangement without waiting of substitute. But the concerned controlling officers, by ignoring the instructions of the Directorate or Regional Coordination and repeatedly asking for the substitute, thereby creating the situation where the concerned employee is bound to stay at the station/office forcefully and had to face the hardship in spite of the fact that he/she is has already been got transferred long back.

We have also noticed, in some cases where the transfer orders are issued on personal request without TA/DA/Joining time as he/she not completed the station tenure but during the course of waiting for substitute he/she completed the tenure. But even after getting relieved, on completion of tenure, they are being deprived of the benefits of transfer, for which he was entitled. It is there for requested that the order's for those officers who are being not relived for want of substitute, their transfer order should be modified suitably so that they may get benefits of normal transfer with TA/DA/Joining Time, for example Sh.Pramod Kumar, AAO presently posted in Indore Central Circle, Indore, who had requested for transfer from Indore to Delhi and his request has been considered by hard case committee and transfer order issued vide order No. 150/2015 issued vide No. 8/9/2015-EC-IV(SC) dated 7-8-2015 Transfer ID No. T-201503574 clearly mentioning that "If required, local arrangement may be made in this regard. In no case, salary should be made by the present office from the month of August-2015 in respect of transferred official,"


But the concerned official is still waiting for his reliving and his substitute, in present case the purpose of Hard Case is itself defeated. Now the official has completed his station tenure on 1-8-2016 and is still waiting of substitute for his reliving.

In some other cases when the transfer orders were issued in public interest the officials are waiting of substitute.

Keeping in view of stated above and hardship being faced by the ministerial cadre, it is humbly requested to make suitable arrangement of reliving of the officials whose transfer orders have already been issued, and if he/she has completed his station tenure due to waiting of substitute their order be issued in personal request may be changed in public interest with allowing them TA/DA/Joining time and suitable instruction may also be issued to all the regional SDGs and regional coordination's for implementation of orders issued by the Directorate as well as by the regional coordination's.


